An Act relative to voting precincts in the City of Chicopee.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, ward 6 precinct  
2 A of the City of Chicopee shall be 1 precinct for the purpose of forming congressional,  
3 representative, senatorial or councilor districts, but shall have 2 polling places for the purpose of  
4 voting at any federal, state, or municipal elections. One of these polling places shall be located to  
5 the south of Champion Drive and to the south of the Westover Air Force Base boundary, to serve  
6 voters residing in ward 6, precinct A, south of that drive and south of that boundary. This polling  
7 place shall be known as ward 6, precinct AS. The other polling place shall be located to the north  
8 of Champion drive and to the north of the Westover Air Force Base boundary, to serve voters  
9 residing in ward 6, precinct A, north of that drive and north of that boundary. This polling place  
10 shall be known as ward 6, precinct AN

11           SECTION 2. Notwithstanding any general or special law to the contrary, ward 6, precinct  
12 B in the City of Chicopee shall be 1 precinct for the purpose of forming congressional,  
13 representative, senatorial and councilor districts but shall have 2 polling places for the purpose of

14 voting at any federal, state, or municipal elections. One of these polling places shall be located to  
15 the east of interstate highway route 291 and north of the Massachusetts turnpike to serve voters  
16 residing in ward 6, precinct B in the Burnett Road area. This polling place shall be known as  
17 ward 6, precinct BE. The other polling place shall be located to the west of interstate highway  
18 route 291 and south of the Massachusetts turnpike to serve voters residing in ward 6, precinct B  
19 in the Sheridan Circle area. This polling place shall be known as ward 6, precinct BW

20 SECTION 3. The city clerk of the city of Chicopee and the board of registrars of the city  
21 of Chicopee shall take all necessary actions to assure compliance with this act, including, but not  
22 limited to, such actions as will assure the accuracy of the voting lists as located at each such  
23 polling place set forth in sections 1 and 2. The city clerk and the board of registrars shall divide  
24 each of the precincts set forth in sections 1 and 2 into 2 sub precincts, in each of which is located  
25 1 of the polling places set forth in those sections, and only the names of voters who reside in  
26 each such sub precinct shall appear on the voting list for such sub precinct.

27 SECTION 4. This act shall take effect upon its passage.
