Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 3 of chapter 40A of the General Laws, as appearing in the 2010
2 Official Edition is hereby amended by striking out the ninth paragraph.

3 SECTION 2. Section 9B of said chapter 40A of the General Laws, as so appearing, is
4 hereby amended by inserting at the end thereof the following paragraph:-

5 The installation of solar energy systems or the building of structures to facilitate
6 the collection of solar energy shall be subject to local zoning ordinance or by-laws.
