**In the Year Two Thousand Eleven**

An Act relative to Parole Board membership and reporting.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 4 of chapter 27 of the General Laws, as appearing in the 2008  
2 Official Edition, is hereby amended by striking out, in lines 41 and 42, the words “the governor  
3 may designate one of the members to act as chairman during such an absence or disability” and  
4 inserting in place thereof the following:-

5 the member with the most service time as a member of said board shall act as chairman  
6 during such absence or disability.

7 SECTION 2. Said section 4 of said chapter 27, as so appearing, is hereby further amended  
8 by inserting after the word “office” in line 47 the following words:-

9 private employment,

10 SECTION 3. Section 131A of chapter 127 of the General Laws, as so appearing, is hereby  
11 amended by inserting after the word “thereof”, in line 5, the following words: -

12           and shall include the parolee's address of primary residence, and any addresses of  
13 secondary residence. Not less than 24 hours following the effective date of any employment, the  
14 parole officer assigned to the parolee shall notify in writing the department of state police, the  
15 police department in the city or town to which the parolee will return of such parole, and the  
16 district court with jurisdiction in the city or town to which the parolee will return of such  
17 employment.
