An Act discontinuing that portion of Gravelly Brook Road lying in the town of Topsfield as a county highway, and authorizing and directing the Division of Capital Asset Management to convey and grant all right, title, and interest in said discontinued portion to abutters.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the provisions of chapter eighty-two of the general laws,
2 the portion of Gravelly Brook Road in the town of Topsfield described in section 3 of this act is
3 hereby discontinued as a county highway, and the commissioner of the Division of Capital Asset
4 Management, hereinafter referred to as the commissioner, is directed to file in the office of the
5 Topsfield Town Clerk notice of such discontinuance.

6 SECTION 2. Notwithstanding the provisions of sections forty E through forty J of
7 chapter seven of the general laws, or section 16 of chapter thirty B of the general laws, or of any
8 other general or special law to the contrary, the aforesaid commissioner is hereby authorized,

9 empowered and directed to grant to each abutter of said portion of Gravelly Brook Road,
10 respectively, by recordable deed and for no monetary consideration, all the Commonwealth's
11 right, title, and interest to the land described in section 3 of this act, such that each abutter shall
12 receive a deed conveying the Commonwealth's interest in that portion of Gravelly Brook Road
13 bounded by the center line of the Road, the abutter's present, shared boundary line with the
14 Road, and the extensions to the center line of the Road of the abutter's side boundary lines from
15 the point where they intersect with said shared boundary line, to be held for all lawful purposes
16 without restriction.

17 SECTION 3. The portion of Gravelly Brook Road to be discontinued, and the parcel of
18 land to be conveyed to the abutters of said Road, is all that portion of said road lying in the town
19 of Topsfield and described in Layout Plan Number 1052, voted on December 19, 1854, by the
20 Essex County Commissioners, having approximately 6.12 acres

21 SECTION 4. This act shall take effect upon its passage.
