## The Commonwealth of Massachusetts

An Act to create the position of poet laureate for the Commonwealth of Massachusetts.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 6 of the General Laws, as appearing in the 2006 Official Edition,  
2 is hereby amended by adding, after section 5, the following new section:

4           Section 5A.

5           (a) The governor may select a poet laureate for the Commonwealth of Massachusetts  
6 from the list of nominees submitted to him or her by the Commonwealth Poet Laureate  
7 Nominating Committee pursuant to Section 5A (b) herein. The nominating committee shall  
8 submit the list of three nominees to the Governor by February 1st. The Governor shall appoint  
9 the Poet Laureate within 30 days after receiving the list of nominees. The poet laureate shall be

10 appointed to serve for a term of two years or until a successor is appointed and qualified as  
11 provided in this section.

13 (b) (1) There shall be a Poet Laureate Nominating Committee. The Poet Laureate  
14 Nominating Committee shall consist of five (5) members: one (1) member of the Senate, one (1)  
15 member of the House, one (1) member appointed by the Governor, and two (2) members of the  
16 Board of Directors of the Massachusetts Cultural Council. Poet Laureate Nominating Committee  
17 shall serve without compensation.

18  
19 (2) The Poet Laureate Nominating Committee shall advertise for and receive nominations  
20 for the selection of the Poet Laureate for the Commonwealth of Massachusetts. The Poet  
21 Laureate Nominating Committee shall review all nominations and select a list of three (3)  
22 nominees who are residents of the Commonwealth, to submit to the Governor along with their  
23 biographical and professional information and supporting representative material and who, based  
24 on their poetic accomplishments, deserve recognition as the Poet Laureate for the  
25 Commonwealth. The Governor may select the Poet Laureate for the Commonwealth from the  
26 list of nominees for a two year term of office.

27  
28 (c) In the event of a vacancy in the office of Poet Laureate for the Commonwealth, the  
29 vacancy shall be filled in the same manner as the original appointment, and the person so  
30 appointed shall serve until a successor is appointed and qualified as provided in this section.

32           (d) The Poet Laureate for the Commonwealth during his or her term shall seek to raise  
33 the consciousness of all people, including, but not limited to school children to a greater  
34 appreciation of the reading and writing of poetry, and

36           (e) The poet laureate shall be an honorary position and the person appointed shall receive  
37 no remuneration. The person appointed to the position of poet laureate shall not be considered a  
38 state official or a state employee for such person's service in the position of poet laureate.
