An Act relative to license plates for carsharing vehicles.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 90 of the General Laws is hereby amended by adding after section 32E½ the  
2 following section:-

3 Section 32E ¾: (a) As used in this section, “carsharing organization” means a corporation  
4 or cooperative that owns a fleet of one or more cars, parked in common areas and retains a  
5 membership base that has exclusive access to the fleet on a timed basis. The registrar of motor  
6 vehicles shall promulgate regulations to further define “carsharing organization” as necessary.

7 (b) Vehicles in the fleet of a carsharing organization shall be permitted to bear residential  
8 license plates as issued by the registrar of motor vehicles under Section 2 of Chapter 90.
