An Act relative to burial benfits of veterans..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 8 of Chapter 115 of the General Laws, as appearing in the 2006
- 2 Official edition, is hereby amended by striking out lines 1 through 14 and inserting in place
- 3 thereof the following:-
- 4 "Amounts expended by the burial agent under the provisions of section 7 shall not exceed
- 5 \$5,000 for the funeral and burial of a person under this chapter, provided that the cost of funeral
- 6 and burial does not exceed \$6,000 and there are insufficient resources in the estate of such
- 7 person to pay for the cost of such funeral and burial.
- 8 Amounts expended by the burial agent under the provisions of section 7 shall not exceed
- 9 \$3,000 for the cremation, funeral and burial of a person under this chapter, provided that the cost

- of the cremation, funeral and burial does not exceed \$4,000 and there are insufficient resources
- in the estate of such person to pay for the cost of such cremation, funeral and burial."
