An Act regulating apprenticeships under the practice of cosmetology..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 87KK of chapter 112 of the General Laws, as appearing in the  
2 2008 Official Edition, is hereby amended by inserting in place thereof after the following  
3 section:—

4           Section 87KK ½   COSMETOLOGY APPRENTICESHIPS

5           Each cosmetology apprentice shall receive instruction from a licensee who is a shop  
6 owner and has been licensed and practicing for a minimum of 10 consecutive full-time years  
7 immediately prior to the time of the apprenticeship in the area of cosmetology which the  
8 apprentice is seeking licensure.

9           At no time shall a supervisor of an apprentice have more than one apprentice nor shall the  
10 apprentice be allowed to work if the supervisor is not available. The supervisor shall keep a  
11 weekly record of the apprentice's attendance and it shall include: (a) the name of the apprentice;  
12 (b) the name and address of the shop; (c) the dates the apprentice worked; (d) the total number of  
13 hours worked during the week; (e) the work processes performed on the days the apprentice  
14 worked; (f) the signature of the supervisor; and (e) the signature of the apprentice.

15           A cosmetology apprentice shall not perform any client services for the first 100 hours of  
16 the apprenticeship. An apprentice shall spend no more than 30 minutes a day cleaning during  
17 hours that are being documented as part of the apprenticeship requirement. An apprentice shall  
18 wear a name tag stating "Apprentice." The Board does not govern whether the apprentice is paid  
19 money or receives a stipend.

20           A cosmetology apprentice will consist of approximately 20 hours per week of shop work  
21 with no more than 85 hours per month for a total of 2,000 hours of documented work with clients  
22 or the supervisor.

23           To accommodate unexpected illness or required absences, an apprentice may work more  
24 or less hours per week but in no instance can the apprenticeship extend more than 36 months. To  
25 accommodate acceleration, an apprentice may work additional hours per week, but in no instance  
26 can the total 2,000 apprenticeship hours be completed in less than 12 months.

27           At the conclusion of the apprenticeship, the apprentice shall have acquired the following  
28 competencies: (a) shampooing; (b) hair-cutting, hairstyling and hair-shaping; (c) hair coloring,  
29 including temporary, semi-permanent and permanent; (d) permanent waxing and straightening;  
30 (e) hair analysis & scalp treatments; (f) facials; (g) waxing; (h) manicuring and pedicuring; (i)

31 sanitation and sterilization techniques for shop equipment and supplies; (j) sanitary health and  
32 hygiene procedures; and (m) the safe use, storage and disposal of shop chemicals.

33 The Board of Registration shall be responsible for promulgating rules and regulations  
34 measuring the competency levels of all cosmetology apprenticeship candidates. All cosmetology  
35 apprenticeship candidates must take and pass the Board of Cosmetologist written examination.

36 A person who violates a prohibition under this section is subject to administrative  
37 penalties established by the Board of Cosmetology.
