In the Year Two Thousand Eleven

An Act relative to disciplinary actions under the Board of Registration in Medicine.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 5E of chapter 111 of the General Laws, as so appearing,
2 is hereby amended by striking out the second sentence, and inserting in place thereof the
3 following sentence:- “Such report shall be made within ten days after any such settlement
4 agreement has been reduced to writing thereto or ten days after service of such arbitration award
5 on the parties and signed by all the parties.”

6 SECTION 2. Section 53B of chapter 111 of the General Laws, as so appearing,
7 is hereby amended by striking out, in the second sentence of the first paragraph, the word
8 “thirty,” and by inserting in place thereof the word “ten.”

9 SECTION 3. Section 70 of chapter 111 of the General Laws, as so appearing, is
10 hereby amended by inserting, in the first paragraph, after the words “written authorization from

11 such executor or administrator,” in the fifth sentence, the words, “or the board of registration in
12 medicine.”

13 SECTION 4. Section 203 of chapter 111 of the General Laws, as so appearing,
14 is hereby amended by striking out, in the first sentence of paragraph (e), the word “thirty,” and
15 by inserting in place thereof the word “ten.”

16 SECTION 5. Section 5B of chapter 112 of the General Laws, as so appearing,
17 is hereby amended by striking out, in the second sentence of the first paragraph, the word
18 “thirty,” and by inserting in place thereof the word “ten.”

19 SECTION 6. Section 5C of chapter 112 of the General Laws, as so appearing,
20 is hereby amended by striking out, in the first sentence of the second paragraph, the word
21 “thirty,” and by inserting in place thereof the word “ten.”

22 SECTION 7. Section 5F of chapter 112 of the General Laws, as so appearing,
23 is hereby amended by inserting, in the first paragraph, after the word “eleven” in the first
24 sentence, the words, “and including a pharmacist, nurse practitioner, physician assistant, and
25 acupuncturist”.

26 SECTION 8. Section 5F of chapter 112 of the General Laws, as so appearing,
27 is hereby amended by inserting, in the second paragraph, after the words “requirements of a” in
28 the fifth sentence, the words, “mental health.”

29 SECTION 9. Section 6 of chapter 112 of the General Laws, as so appearing, is
30 hereby amended by striking out in the first sentence the following words: “by a fine of not less

31 than one hundred nor more than one thousand dollars or by imprisonment for not less than one
32 nor more than one year, or both”, and by inserting in place thereof the following:-

33 by imprisonment in the state prison for not less than two and one-half years nor more
34 than five years or by a fine of not more than five thousand dollars and imprisonment in a jail or
35 house of correction for not more than two and one-half years, or both such fine and
36 imprisonment.

37 SECTION 10. Section 159 of chapter 112 of the General Laws, as so
38 appearing, is hereby amended by striking out in the first sentence the following words: “by a fine
39 of not less than one hundred nor more than one thousand dollars, or by imprisonment for not less
40 than three months, or both such fine and imprisonment”, and by inserting in place thereof the
41 following:-

42 by a fine of not more than five thousand dollars, or by imprisonment in the state prison
43 for not less than two and one-half years nor more than five years, or imprisonment in a jail or
44 house of correction for not more than two and one-half years, or both such fine and
45 imprisonment.

46 SECTION 11. Section 160 of chapter 112 of the General Laws, as so
47 appearing, is hereby amended by striking out in the second sentence the following words: “by a
48 fine of not less than one hundred nor more than one thousand dollars, or by imprisonment for not
49 less than one month nor more than one year, or both”, and by inserting in place thereof the
50 following:-

51 by a fine of not more than five thousand dollars, or by imprisonment in the state prison
52 for not less than two and one-half years nor more than five years, or imprisonment in a jail or

53 house of correction for not more than two and one-half years, or both such fine and
54 imprisonment.

55 SECTION 12. Section 26 of chapter 221 of the General Laws, as so appearing,
56 is hereby amended by inserting, after the words “physician registered in the commonwealth” in
57 the first sentence, the following words:-

58 “is arraigned for any crime, except civil infractions under section 70C of chapter 277, or”
