An Act to make habilitative services available to the children of the Commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1                   SECTION 1. Subsection (a) of section 25 of chapter 32A of the General Laws,  
2 as amended by chapter 207 of the acts of 2010, is hereby amended by adding the following  
3 definitions:

4                   “Developmental delay”, a disability in a person diagnosed by licensed physician which  
5 results in a delay in attaining the capacity to achieve age appropriate physical, intellectual,  
6 communicative, emotional, and social functioning within the person's environment

7                   “Treatment of developmental delay” includes the following care when prescribed,  
8 provided or ordered by a licensed physician or a licensed psychologist who determines the care  
9 to be medically necessary: habilitative or rehabilitative care; pharmacy care; psychiatric care;  
10 psychological care; and therapeutic care.

11                   SECTION 2. Subsection (b) of said section 25 is hereby amended at the end  
12 thereof by inserting after the word “individuals” the following:
