### The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to the revenues of Commonwealth..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:* 

1 SECTION 1. Chapter 14 of the General Laws is hereby amended by adding at the end the

2 following section:-

3 "SECTION 12. Non-earned income in excess of \$1.5 billion; transfer to Stabilization

4 Fund

5 Section 12. The commissioner of revenue shall certify to the secretary of the executive

6 office of administration and finance not later than the fifth day of each month his best estimate of

- 7 the amount of tax revenue from non-earned income received by the Commonwealth in the
- 8 previous month, and the total amount of tax revenue from non-earned income received by the

9 Commonwealth in the current fiscal year. Any tax revenue from non-earned income in excess of

10 \$1,500,000,000, as so certified, shall be transferred to the Stabilization Fund."

11	SECTION 2. Section 29 of Chapter 2H is hereby amended by adding at the end the
12	following paragraph:- "No appropriation shall be made from this fund unless approved either by
13	two-thirds of the members in both branches of the legislature voting thereon or by unanimous
14	consent in each branch of the legislature."
15	SECTION 3. Section 19(a) of Chapter 32B of the General Laws is hereby amended in the
16	fourth paragraph by striking out the phrase "70 per cent" and inserting in place thereof the phrase
17	"a majority"; and in the fifth paragraph by striking out the phrase "70 per cent" and inserting in
18	place thereof the phrase "a majority".
19	SECTION 4. Section 2H of Chapter 29 of the General Laws is hereby amended by
20	adding at the end of the first paragraph the following sentence:- "Not less than 10 per cent of the
21	funds in the Stabilization Fund shall be set aside for the fiscal stability of local governmental
22	units."
23	SECTION 5. The Secretary of Administration and Finance and the Secretary of Health
24	and Human services are hereby authorized and directed to evaluate the feasibility of contracting
25	for recycling durable medical equipment purchased and issued by the Commonwealth through
26	any and all of its medical assistance programs.
27	Said evaluation shall include but not be limited to a request for qualifications and/or
28	proposals for entities capable of developing, implementing and operating a system of recycling
29	whereby an inventory of such equipment is developed and managed so as to maximize the
30	quality of service delivery to equipment recipients and to minimize costs and losses attributable
31	to waste, fraud and/or abuse.

32	The Secretary of Administration and Finance shall report the findings of said evaluation,
33	together with cost estimates for the operation of a recycling program, estimates of the savings it
34	would generate, and legislative recommendations, no later than October 31, 2011.
35	SECTION 6. (A) Definitions – For the purposes of this section, the terms below shall be
36	defined as follows:
37	Entity – whether for-profit or not for profit,
38	a corporation
39	an association
40	a partnership
41	a limited liability corporation
42	a limited liability partnership
43	a sole proprietorship
44	any other legal business entity
45	a political subdivision of the Commonwealth
46	provided that an employee of the Commonwealth or an individual recipient of assistance
47	shall not be considered an entity.
48	State expenditure – an expenditure of state funds including grants, subgrants, loans,
49	awards, cooperative agreements, financial assistance, contracts, subcontracts, purchase order,
50	task orders and delivery orders, and excluding transactions below \$25,000.

51	Searchable website – a website which allows the public to:
52	Search and aggregate state expenditures by any item identified in the definition of
53	website contained herein
54	Ascertain through a single search the total amount of state funding awarded to an
55	entity by fiscal year, and
56	Download information, including the results of searches.
57	Website – a searchable website which includes for each state expenditure:
58	The name of the receiving entity
59	The amount of the expenditure
60	Information describing the expenditure such as transaction type, funding agency
61	or program, and title descriptive of the purpose of the expenditure
62	The location of the entity receiving the expenditure and the primary location of
63	performance pursuant to the expenditure, including the city, state, country and legislative district
64	A unique identifier of the entity receiving the award and of any parent entity of
65	the recipient
66	Any other relevant information specified by the Operational Services Division.
67	(B) The Secretary of Administration and Finance, the Comptroller, the Treasurer and the
68	Operational Services Division are hereby authorized and directed to develop a single searchable
69	website, accessible by the public without cost, to enable the public to research and examine state

70	expenditures as defined herein. Said website shall be designed so as to maximize utility,
71	minimize cost and promote accessibility of information, and shall build upon resources currently
72	existing, including, but not limited to, the "EASI" website, so-called, administered by the
73	Executive Office of Administration and Finance, and the Comm-Pass system, so-called,
74	administered by the Operational Services Division of the Executive Office of Administration and
75	Finance.
76	In developing said website, the Secretary shall seek to obtain the use of coding and other
77	information management infrastructure developed by the federal government pursuant to the
78	"Federal Funding Accountability and Transparency Act of 2006".
79	Said website shall seek to provide information for Fiscal Year 2011 and subsequent
80	years.
81	A plan for the development and implementation of said website, together with any
82	estimates for funding required and other legislative recommendations, shall be filed with the
83	clerks of the House and Senate not later than November 30, 2011.
84	SECTION 7. (A) Section 1 of Chapter 32 of the General Laws, as appearing in the 2008
85	official edition, is hereby amended by inserting in the definition of "regular compensation" after
86	the first paragraph the following new paragraph: -
87	"Regular compensation," during any period subsequent to January 1, 2011, shall mean
88	the full salary, wages or other compensation in whatever form, lawfully determined for the
89	individual service of the employee by the employing authority, not including bonus, overtime,
90	allowances for housing, transportation, travel, any and all employment related expense
91	reimbursements, severance pay for any and all unused sick leave, or any other payments made as

92 a result of giving notice of retirement, and any other such compensation in excess of salary or
93 wages or as reasonably determined by the board.

94 (B) Section 1 of chapter 32 of the General Laws, as so appearing, is hereby amended by
95 inserting following the definition of the words "Annuity savings fund" the following: - "Average
96 annual rate of regular compensation", shall be the average of the rate of regular compensation for
97 any qualifying year of credible service received during each pay period during the qualifying
98 year.

99 (C) Paragraph (b) of subdivision (1) of section 5 of chapter 32, of the General Laws, as so 100 appearing, is hereby amended at the end thereof by adding following: - In the event that eighty 101 per cent or greater of his regular compensation is in payment for duties in the group having the 102 higher maximum age limit, such member shall not be considered to have achieved the maximum 103 age for superannuation until he has attained the maximum age limit in the group having the 104 higher maximum age limit, said member shall be limited to the performance of such later duties 105 as prescribed in this paragraph.

(D) Subdivision (2) of section 5 of chapter 32, of the General Laws, as so appearing, is
hereby amended at the end thereof by adding the following sentences: - Provided that in any
given year, no retirement allowance, as provided for by this chapter, shall exceed four hundred
per cent of the average retirement allowance in the Commonwealth. The board shall determine
the average retirement allowance in the Commonwealth as of January 1 of each year.
