By Ms. Clark, a petition (accompanied by bill, Senate, No. 1990) of Katherine M. Clark, Paul J. Donato, Christopher G. Fallon and Stephen Stat Smith (with approval of the Mayor and city council) for legislation relative to the administrative organization of financial officers in the city of Malden. Municipalities and Regional Government. [Local Approval Received.]

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Eleven**

An Act relative to the administrative organization of financial officers in the city of Malden.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 1. Section 10 of Chapter 169 of the Acts of 1881 is hereby amended by  
2 striking out the first five sentences and inserting in place thereof the following:

3           ?The Mayor shall be the chief executive officer of the city. He shall be active and vigilant  
4 in causing

5           the laws and regulations of the city to be enforced and keep a general supervision over  
6 the conduct and

7           performance of duties of all officers. He may, whenever in his opinion the public good  
8 requires,

9           remove, with the consent of the appointing power, any officer over whose appointment  
10 he has, in

11 accordance with the provisions of this charter, exercised the power of nomination. He  
12 may call special  
13 meetings of the City Council to be convened when in his opinion the interests of the city  
14 require it, by  
15 causing notices to be left at the usual place of residence of each member of the City  
16 Council. He shall  
17 from time to time communicate to the City Council such information and recommend  
18 such measures as  
19 the business and interests of the city may in his opinion require, including  
20 recommending, in compliance  
21 with applicable general laws and regulations, discipline or dismissal for cause of any  
22 officer appointed  
23 by the City Council.?

24 Section 2. Section 2 of Chapter 188 of the Acts of 1953, as it amends Chapter 180  
25 of the Acts of 1917, is hereby further amended by striking out said section 2 and inserting in  
26 place thereof the following:

27 ?Commencing in January of 2015 and every three years thereafter, the City Council shall  
28 choose by  
29 majority vote a Controller of Accounts, who shall hold office for the three years next  
30 ensuing and until a

31            successor is appointed and qualified; provided that he may be removed at any time by the  
32 City Council

33            for sufficient cause. Any vacancy occurring in such office may be filled at any time by  
34 majority vote of

35            the City Council. The compensation of the Controller of Accounts shall be fixed by  
36 ordinance.?

37            Section 3. Chapter 446 of the Acts of 1950 is hereby amended by striking out  
38 Section 1 of said act and inserting in place thereof the following: ?Upon passage of this act, the  
39 City Council may, as soon as practicable, choose by majority vote a Treasurer, who shall serve  
40 until December 31, 2011, unless sooner removed for cause. Commencing in January of 2012 and  
41 every three years thereafter, the City Council shall choose by majority vote a

42            Treasurer who shall serve for the three years next ensuing and until a successor is  
43 appointed and

44            qualified; provided that he may be removed by the City Council at any time for sufficient  
45 cause. Any

46            vacancy occurring in such office may be filled at any time by majority vote of the City  
47 Council. The

48            compensation of the Treasurer shall be fixed by ordinance.

49            The Treasurer shall have all the powers and duties imposed by law and ordinance on  
50 municipal

51 treasurers and collectors of taxes and shall serve as Chief Financial Officer for the city.

52 As Chief Financial Officer, his duties shall include administering, coordinating and  
53 supervising all

54 financial services, activities and officers, and assisting in all matters relating to municipal  
55 financial

56 affairs. He shall, under the direction of the Mayor, prepare the annual appropriation order  
57 for

58 consideration by the City Council and, under the direction of the Mayor and City  
59 Council, develop and

60 implement a long range capital plan. He shall make recommendations to the Mayor and  
61 City Council

62 for enhancing revenue and revenue collections and shall perform such other duties as  
63 prescribed by the

64 Mayor and City Council.

65 Section 4. Section 11 of Chapter 169 of the Acts of 1881, as most recently  
66 amended by Chapter 425 of the Acts of 2000, is hereby further amended by striking out the  
67 phrase: "...provided that, when reconsidering the

68 election of an assessor, city clerk, controller, solicitor or treasurer, the election shall stand  
69 if agreed to

70 by a majority of the members present and voting? and inserting in place thereof:

71 ?.....provided that,

72 when reconsidering the election of an assessor, city clerk, controller, solicitor or

73 treasurer, the election

74 shall stand if agreed to by a two thirds of the members present and voting.?

75 Section 5. The present Controller of Accounts shall hold office until December 31,

76 2014, unless sooner removed for cause.

77 Section 6. This act shall take effect upon passage.
