An Act mandating coverage for ectodermal dysplasia and other congenital disorders..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 17E of chapter 32A of the General Laws, as appearing in the 2004
2 Official Edition, is hereby amended by inserting after the words "result of", in lines 10 and 11,
3 the following words:- ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta,
4 amelogenesis imperfecta and other maxillofacial abnormalities or.

5 SECTION 2. Said chapter 32A is hereby amended by inserting after section 17H the
6 following section:-

7 Section 17I. The commission shall provide to any active or retired employee of the
8 commonwealth who is insured under the group insurance commission coverage for dentures,
9 dental implants, crowns and bridges that are medically necessary for the care and treatment of

10 ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta, amelogenesis imperfecta
11 and other maxillofacial abnormalities.

12 SECTION 3. Section 47T of chapter 175 of the General Laws, as appearing in the 2004
13 Official Edition, is hereby amended by inserting after the words "result of", in line 20, the
14 following words:- ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta,
15 amelogenesis imperfecta and other maxillofacial abnormalities or.

16 SECTION 4. Said chapter 175 is hereby amended by inserting after section 47X, inserted
17 by section 1 of chapter 49 of the acts of 2004, the following section:-

18 Section 47Y. Any individual policy of accident and sickness insurance issued pursuant to
19 section 108 and any group blanket policy of accident and sickness insurance issued pursuant to
20 section 110, except policies providing supplemental coverage to Medicare or to other
21 government programs, that is delivered, issued or renewed within or without the commonwealth
22 shall provide coverage for dentures, dental implants, crowns and bridges that are medically
23 necessary for the care and treatment of ectodermal dysplasia, cleft lip, cleft palate,
24 dentinogenesis imperfecta, amelogenesis imperfecta and other maxillofacial abnormalities.

25 SECTION 5. Section 8T of chapter 176A of the General Laws, as appearing in the 2004
26 Official Edition, is hereby amended by inserting after the words "result of", in line 15, the
27 following words:- ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta,
28 amelogenesis imperfecta and other maxillofacial abnormalities or.

29 SECTION 6. Said chapter 176A is hereby amended by inserting after section 8Y, inserted
30 by section 2 of chapter 49 of the acts of 2004, the following section:-

31 Section 8Z. Any contract between a subscriber and the corporation under an individual or
32 group hospital service plan, except contracts providing supplemental coverage to Medicare or to
33 other government programs, that is delivered, issued or renewed within or without the
34 commonwealth shall provide to all individual subscribers and members within the
35 commonwealth and to all group members having a principal place of employment within the
36 commonwealth coverage for dentures, dental implants, crowns and bridges that are medically
37 necessary for the care and treatment of ectodermal dysplasia, cleft lip, cleft palate,
38 dentinogenesis imperfecta, amelogenesis imperfecta and other maxillofacial abnormalities.

39 SECTION 7. Section 4R of chapter 176B of the General Laws, as appearing in the 2004
40 Official Edition, is hereby amended by inserting after the word "result of", in line 15, the
41 following words:- ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta,
42 amelogenesis imperfecta and other maxillofacial abnormalities or.

43 SECTION 8. Said chapter 176B is hereby amended by inserting after section 4Y, inserted
44 by section 3 of chapter 49 of the acts of 2002, the following section:-

45 Section 4Z. Any subscription certificate under an individual or group medical service
46 agreement, except certificates providing supplemental coverage to Medicare or to other
47 government programs, that is delivered, issued or renewed within or without the commonwealth
48 shall provide to all individual subscribers and members within the commonwealth and to all
49 group members having a principal place of employment within the commonwealth coverage for
50 dentures, dental implants, crowns and bridges that are medically necessary for the care and
51 treatment of ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta, amelogenesis
52 imperfecta and other maxillofacial abnormalities.

53 SECTION 9. Section 4J of chapter 176G of the General Laws, as appearing in the 2004
54 Official Edition, is hereby amended by inserting after the words "result of", in line 9, the
55 following words:- ectodermal dysplasia, cleft lip, cleft palate, dentinogenesis imperfecta,
56 amelogenesis imperfecta and other maxillofacial abnormalities or.

57 SECTION 10. Said chapter 176G is hereby amended by inserting after section 4Q,
58 inserted by section 4 of chapter 49 of the Acts of 2002, the following section:-

59 Section 4R. Any individual or group health maintenance contract, except contracts
60 providing supplemental coverage to Medicare or to other government programs, that is issued,
61 renewed or delivered within or without the commonwealth shall provide to residents of the
62 commonwealth and to persons having a principal place of employment within the
63 commonwealth coverage for dentures, dental implants, crowns and bridges that are medically
64 necessary for the care and treatment of ectodermal dysplasia, cleft lip, cleft palate,
65 dentinogenesis imperfecta, amelogenesis imperfecta and other maxillofacial abnormalities.

66 SECTION 11. This act shall apply to all policies, contracts, agreements, plans and
67 certificates of insurance issued or delivered within or without the commonwealth on or after
68 January 1, 2010, and to all policies, contracts, agreements, plans and certificates of insurance in
69 effect before that date upon renewal on or after January 1, 2010.
