Jones, Jr. and others for an investigation by a special commission (including members of the General Court) relative to performance-based funding for public institutions of higher education. Higher Education.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act relative to performance-based funding for the public system of higher education.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, there shall be a  
2 special commission to study and report on ways to improve and increase funding formulas for  
3 the public system of higher education within the commonwealth. The commission shall consist  
4 of: the commissioner of higher education; 2 members of the house of representatives, 1 of whom  
5 shall be appointed by the speaker of the house, and 1 of whom shall be appointed by the minority  
6 leader of the house; 2 members of the senate, 1 of whom shall be appointed by the senate  
7 president, and 1 of whom shall be appointed by the senate minority leader; and 3 members to  
8 represent public institutions of higher education. Of the 3 members chosen to represent public  
9 institutions of higher education, 1 shall be a member of the board of trustees of the University of  
10 Massachusetts as voted by the board of trustees for the university, 1 shall be a member of a board  
11 of trustees of a state university chosen by vote of the chairs of the board of trustees of each of the  
12 state universities, and 1 shall be a member of a board of trustees of a community college chosen  
13 by vote of the chairs of the board of trustees of each of the community colleges. The scope of the  
14 commission shall include, but shall not be limited to: studying the various methods of  
15 performance-based funding at public institutions of higher education throughout the United  
16 States; researching the results of performance-based funding throughout the United States;  
17 incentivizing the retention, support, and graduation of students, instead of enrollment of students,  
18 at each level of the public system of higher education; increasing the performance-based funding  
19 levels to public institutions of higher education; updating the mission statements and goals of  
20 individual institutions at each level of the public system of higher education; and revising the  
21 performance measurement system, to reflect the individual missions and goals of each institution

22 and ensure that performance-based funding is allocated appropriately. The commission shall  
23 submit its findings and recommendations, along with legislation to effectuate the same, to the  
24 board of higher education, the joint committee on higher education, and the senate and house  
25 clerks no later than 6 months after the passage of this act.

26 As used in this section, the term “performance-based funding” shall refer to the  
27 calculated appropriation of funding to public institutions of higher learning based upon the  
28 achievement of specific metrics of the performance measurement system, as detailed in section  
29 7A of chapter 15A of the General Laws.
