An Act relative to program approval.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 30A of Chapter 69 of the General Laws, as appearing in the 2010  
2 Official Edition, is hereby amended by adding at the end thereof the following paragraph:-

3           Notwithstanding the provisions or any general or special law to the contrary, a private,  
4 nonprofit college or university may offer or institute an additional program or degree if the  
5 college or university (1) has maintained a physical presence and operated continuously in the  
6 Commonwealth for the immediately preceding 10 years and (2) is accredited without sanction by  
7 New England Association of Schools and Colleges. Any such college or university that does not  
8 satisfy all of the provisions of this paragraph shall comply with the procedures and criteria  
9 established by the board of higher education.

10           SECTION 2. This Act shall take effect on January 1, 2014.
