By Ms. Khan of Newton, a petition (accompanied by bill, House, No. 116) of Kay Khan, Marcos A. Devers and Stanley C. Rosenberg relative to state agency assessments for the safe and appropriate placement of certain children . Children, Families and Persons with Disabilities.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to state agency assessment for safe and appropriate placement for certain children.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 18A of the General Laws is hereby amended by adding the
2 following section:-

3 Section 10. (a) The department shall, pursuant to its services provided in this chapter and
4 in cooperation with the department of children and families, in said department of children and
5 families' provision of and administration for a comprehensive child welfare program for care for
6 a child in out-of-home placement, who has been adjudicated delinquent for a sexual offense or
7 the commission of arson, or has admitted to such behavior, or is the subject of a documented or
8 substantiated report of such behavior, adhere to the assessment for safe and appropriate
9 placement process, hereinafter referred to as ASAP.

10 (b) In using said ASAP the department shall: (i) cooperate with the department of
11 children and families in the design and implementation of an ASAP process; (ii) consult with
12 subject-matter experts to revise the screening, referral and risk assessment guidelines based on
13 evidence-based practice; (iii) create a process for keeping the ASAP process current with
14 evolving evidence-based practice standards; and (iv) ensure that all staff with responsibilities for
15 the safety of children in foster care or other out-of-home placements are informed about the
16 process and have training in how to make referrals and incorporate risk-assessment and risk-
17 management results into their case management and treatment planning. In partnership with the
18 department, The Massachusetts Adolescent Sex Offender Coalition and the Juvenile Firesetters
19 Coalition shall provide training to staff on the screening and assessment procedures for
20 supporting decisions for safe placements.

21 SECTION 2. Section 2 of chapter 18B of the General Laws, as appearing in the 2010
22 Official Edition, is hereby amended by striking out, in lines 31 to 33, inclusive, the words “and
23 (17) child care placements for children whose families have an open case with the department,”
24 and inserting in place thereof the following words:- ; (17) child care placements for children
25 whose families have an open case with the department; and (18) coordination with other state
26 agencies on the use of an assessment process for safe and appropriate placement for out-of-home
27 placement or foster care for a child, who has been adjudicated delinquent for a sexual offense or
28 the commission of arson, or has admitted to such behavior, or is the subject of a documented or
29 substantiated report of such behavior.

30 SECTION 3. Chapter 19 of the General Laws is hereby amended by adding the
31 following section:-

32 Section 25. (a) The department shall, pursuant to its services provided in section 16 to
33 children and in cooperation with the department of children and families, in said department of
34 children and families’ provision of and administration for a comprehensive child welfare
35 program for a child, who has been adjudicated delinquent for a sexual offense or the commission
36 of arson, or has admitted to such behavior, or is the subject of a documented or substantiated
37 report of such behavior, use an assessment for safe and appropriate placement process,
38 hereinafter referred to as ASAP.

39 (b) In using said ASAP the department shall: (i) cooperate with the department of
40 children and families in the design and implementation of an ASAP process; (ii) consult with
41 subject-matter experts to revise the screening, referral and risk assessment guidelines based on
42 evidence-based practice; (iii) create a process for keeping the ASAP process current with
43 evolving evidence-based practice standards; and (iv) ensure that all staff with responsibilities for
44 the safety of children in foster care or other out-of-home placements are informed about the
45 process and have training in how to make referrals and incorporate risk-assessment and risk-
46 management results into their case management and treatment planning. In partnership with the

54 and families’ provision of and administration for a comprehensive child welfare program for
55 foster care for a child, who has been adjudicated delinquent for a sexual offense or the
56 commission of arson, or has admitted to such behavior, or is the subject of a documented or

57 substantiated report of such behavior, adhere to the ASAP process, hereinafter referred to as
58 ASAP.
