**In the Year Two Thousand Thirteen**

An Act relative to prevailing wages.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 26 of Chapter 149 of the General Laws, as appearing  
2 in the 2006 Official Edition, is hereby amended by inserting in paragraph 1, line 41, after  
3 words "pension plans" the following:- ", bona fide apprenticeship programs  
4 approved by the commonwealth which comply with the requirements of Sections  
5 11E to 11L, inclusive, of Chapter 23 of the General Laws".

6 SECTION 2. Section 27 of Chapter 149 of the General Laws, as appearing  
7 in the 2006 Official Edition, is hereby amended by inserting in paragraph 1, line 35, after  
8 the words "pension plans" the following: ", bona fide apprenticeship programs  
9 approved by the commonwealth which comply with the requirements of sections  
10 11E to 11L, inclusive, of Chapter 23 of the General Laws".

11 SECTION 3. Section 27 of Chapter 149 of the General Laws, as appearing  
12 in the 2006 Official Edition, is hereby amended by inserting in paragraph 1, line  
13 39, after the words "pension plan" the following:- ", a bona fide apprenticeship

14 program approved by the commonwealth which comply with the requirements of  
15 sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

16 SECTION 4. Section 27 of Chapter 149 of the General Laws, as appearing  
17 in the 2006 Official Edition, is hereby amended by inserting in paragraph 1,  
18 line 44, after the words "health and welfare funds" the following:- ", bona fide  
19 apprenticeship programs approved by the commonwealth which comply with the  
20 requirements of sections 11E to 11L, inclusive, of Chapter 23 of the  
21 General Laws".

22 SECTION 5. Section 27 of Chapter 149 of the General Laws, as appearing  
23 in the 2006 Official Edition, is hereby amended by inserting in paragraph 1, line 50, after  
24 the words "and welfare funds" the following:- ", bona fide apprenticeship  
25 programs approved by the commonwealth which comply with the requirements of  
26 sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

27 SECTION 6. Section 27 of Chapter 149 of the General Laws, as appearing  
28 in the 2006 Official Edition, is hereby amended by inserting in line 63, after the words  
29 "health and welfare funds" the following:- ", bona fide apprenticeship  
30 programs approved by the commonwealth which comply with the requirements of  
31 sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

32 SECTION 7. Section 27 of Chapter 149 of the General Laws, as appearing  
33 in the 2006 Official Edition, is hereby amended by inserting in line 69, after  
34 the words "welfare funds" the following:- ", bona fide apprenticeship programs  
35 approved by the commonwealth which comply with the requirements of sections  
36 11E to 11L, inclusive, of Chapter 23 of the General Laws".

37 SECTION 8. Section 27 of Chapter 149 of the General Laws, as appearing  
38 in the 2006 Official Edition, is hereby amended by inserting in line 78, after  
39 the words "welfare funds" the following:- ", bona fide apprenticeship programs

40 approved by the commonwealth which comply with the requirements of sections  
41 11B to 11L, inclusive, of Chapter 23 of the General Laws".
