#### The Commonwealth of Alassachusetts

An Act to include fire districts.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

#### 1 SECTION 1 2 Section 100G of Chapter 41 of the General Laws, appearing in the Official Edition, 3 is hereby amended by adding in the first sentence after the words "and any town" the words "or 4 fire district"; and further amended by adding in the first sentence after the words "town meeting" 5 the words "or district meeting"; and further amended by adding in the last sentence after each 6 word "city", the words ", fire or water district". 7 SECTION 2. 8 Section 100G of Chapter 41 of the General Laws, appearing in the Official Edition, 9 is hereby amended by adding in the first sentence after the words "and any town" the words "or 10 fire or water district"; and further amended by adding in the first sentence after the words "town meeting" the words "or district meeting"; and further amended by adding in the last sentence 11 12 after each word "city" the words ", fire or water district". 13 SECTION 3. 14 Section 85H of Chapter 32 of the General Laws, as appearing in the Official 15 Edition, is hereby amended by adding after the words "the selectman of every town" the words

"and the prudential committee of every fire or water district"; and further amended by adding 16 17 after the words "fire company in a town" the words "or fire district or water district"; and further 18 amended after the words "favor of such town" the words ", fire district or water district". 19 SECTION 4. 20 Section 53A1/2 of Chapter 44 of the General Laws, as appearing in the Official Edition, is hereby amended by adding after the words "or board of selectmen" add the words ",or 21 prudential committee"; and further amended adding after the words "city or town" the words "or 22 23 district". 24 SECTION 5. 25 Section 57B of Chapter 32 of the General Laws, as appearing in the Official 26 Edition, is hereby amended by striking out the words "city or town" and inserting in place 27 thereof the words "city, town, fire or water district"; and further amended by striking out the words "in a town by a majority vote at the annual town meeting" and inserting in place thereof 28 29 the words "in a town or district by a majority vote at the annual town meeting or district 30 meeting".
