An Act relative to funeral home expenses.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 9 of chapter 117A of the General Laws as appearing is hereby  
2 amended by striking the section in its entirety and inserting in place thereof the following new  
3 section:—       Section 9. The department shall provide for the decent interment of all  
4 deceased persons who are at the time of death recipients of aid or assistance under this chapter,  
5 all deceased persons who, although without means of support at the time of death, did not apply  
6 for such aid or assistance; and all unknown persons found dead. The expense thereof may be  
7 recovered of their kindred, if any, chargeable by law for their support in the manner provided in  
8 this chapter; and if the expense of their funeral and interment is not paid by such kindred, an  
9 amount not exceeding eleven hundred dollars shall be paid by the commonwealth; provided  
10 further, that the commonwealth shall have the right of reimbursement from whatever resources  
11 may exist in the estate of said person.

12          SECTION 2. Section 10 of chapter 117A of the General Laws, as so appearing, is hereby  
13 amended by striking the section in its entirety and inserting in place thereof the following new  
14 section:—   Section 10. In case of the decease of a poor and indigent person the commonwealth  
15 shall pay toward the expense of the funeral and interment of such person a sum not exceeding  
16 eleven hundred dollars; provided, however, that the commonwealth shall have the right of  
17 reimbursement from whatever resources may exist in the estate of said person.

18 SECTION 3. Section 2 of Chapter 118 of the General Laws, as so appearing, is hereby  
19 amended by striking the third paragraph in lines 29 through 35 inclusive and inserting in place  
20 thereof the following new paragraph:— “The department may pay a sum not exceeding  
21 eleven hundred dollars toward the funeral and interment of a recipient provided that there are  
22 insufficient resources to pay for the cost of such funeral and interment. The commonwealth shall  
23 have the right of reimbursement from whatever resources may exist in the estate of the  
24 recipient.”

25 SECTION 4. Section 7 of Chapter 118A of the General Laws, as so appearing, is hereby  
26 amended by striking the section in its entirety and inserting in place thereof the following new  
27 section:—

28 Section 7. The department shall provide to aged and disabled residents of the  
29 commonwealth under this chapter a program of social services as enumerated under section two  
30 of chapter eighteen. In addition to the other benefits authorized by this chapter, the department  
31 may provide to such recipients grants of assistance in cases of fire, flood, or other disaster. The  
32 department may pay a sum not exceeding eleven hundred dollars toward the funeral and  
33 interment of a recipient provided that there are insufficient resources to pay for the cost of such  
34 funeral and interment. The Commonwealth shall have the right of reimbursement from whatever  
35 resources may exist in the estate of the recipient.

SECTION 5. Section 23 of Chapter 119  
36 of the General Laws, as so appearing, is hereby amended by striking the fifteenth paragraph in  
37 lines 138 to 145 inclusive and inserting in place thereof the following new paragraph:—

38 “H. The department may pay a sum not exceeding eleven hundred dollars toward the  
39 funeral and interment of a child in its care provided that there are insufficient resources to pay  
40 for the cost of such funeral and interment. The Commonwealth shall have the right of  
41 reimbursement from whatever resources may exist in the estate of the child.” .
