An Act relative to employee plus one plans.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 2 of chapter 32A of the General Laws, as most recently amended by  
2 chapter 224 of the acts of 2012, is hereby further amended by inserting after the definition of  
3 “Wellness program” the following new definitions:-

4 (j) “Employee plus one health coverage”, health insurance coverage for an employee plus  
5 one dependent.

6 (k) “Family health coverage”, health insurance coverage for an employee and his or her  
7 eligible dependents.

8 (l) “Individual health coverage”, health insurance coverage for an employee.

9 SECTION 2. Section 4 of chapter 32A of the General Laws, as appearing in the 2010  
10 Official Edition, is hereby amended by inserting after the word “commonwealth”, in line 11, the  
11 following words:

12 ; provided that the commission shall negotiate with and purchase from one or more  
13 insurance companies, savings banks or non-profit hospital or medical service corporations health  
14 insurance coverage for employee plus one health coverage plans
