By Mr. Keenan of Salem and Senator Lovely, a joint petition (accompanied by bill, House, No. 2838) of John D. Keenan and Joan Lovely for legislation to authorize the Commissioner of Capital Asset Management and Maintenance to convey certain land containing the Salem District Court Building to the Salem Redevelopment Authority. State Administration and Regulatory Oversight.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act directing the Commissioner of Capital Asset Management and Maintenance to convey a certain parcel of land to the Salem Redevelopment Authority.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Notwithstanding sections 33 through 37, inclusive, of Chapter 7C of the
General Laws or any general or special law to the contrary, including, without limitation section
20 of chapter 304 of the acts of 2008, the commissioner of capital asset management and
maintenance shall convey a certain parcel of state-owned land with the building thereon located

5 in the City of Salem to the Salem Redevelopment Authority. Said parcel and building is located

- 6 at 65 Washington Street and is commonly known as the Salem District Court Building.
- 7 SECTION 2. As consideration for the conveyance described in section 1, the Salem
- 8 Redevelopment Authority shall pay \$1.00 at the time of the conveyance and upon any
- 9 subsequent sale of the property or any portion thereof by the Salem Redevelopment Authority,
- 10 the Salem Redevelopment Authority shall pay the net proceeds of such sale to the
- 11 Commonwealth.
- 12 SECTION 3. The Salem Redevelopment Authority shall bear all costs, if any, for the
- 13 transaction, including without limitation, all costs for legal work, survey, title and the preparation
- 14 of plans and specifications. Said costs, if any, and any expenses incurred by the Salem
- 15 Redevelopment Authority to sell the properties shall be paid from the gross proceeds of the sale.
