By Mr. Cantwell of Marshfield, a petition (accompanied by bill, House, No. 3033) of James M. Cantwell and Michael D. Brady relative to the access of registry computer terminals by private detectives licensed by the Department of State Police. Transportation.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act relative to the access of computer terminals by private detectives licensed by the Department of State Police as authorized under the provisions of the federal driver privacy protection act (DPPA), as amended, 18 U.S.C. section 2721, et seq..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 30A of chapter 90 of the General Laws, as so appearing, is hereby  
2 amended

3 by inserting after the word policies, in line 9, the following words:

4 the trial courts and persons licensed by the Department of State Police pursuant to section  
5 twenty-five of chapter one hundred and forty-seven and in compliance with Sections 4 and 8 of  
6 the Federal Driver Privacy Protection Act (DPPA, 18 U.S.C. Section 2721, et seq.), to conduct  
7 criminal investigations for the Committee for Public Counsel Services (CPCS)

8 Section 30A. the registrar shall not allow direct or indirect use of the computer terminals  
9 under his control, whether for inquiry into computer data files or otherwise, except by persons  
10 employed by the commonwealth or a political subdivision thereof, law enforcement agencies, the  
11 special investigative unit of the plan created pursuant to section one hundred and thirteen H of  
12 chapter one hundred and seventy-five only to the extent authorized therein, insurance companies  
13 and their authorized agents and service carriers to the extent authorized in the safe driver  
14 insurance plan and for the purposes of complying with the requirements of sections one A, thirty-  
15 four A, thirty-four B and thirty-four H pertaining to motor vehicle liability policies the trial  
16 courts and persons licensed by the Department of State Police pursuant to section twenty-five of  
17 chapter one hundred and forty-seven and in compliance with Sections 4 and 8 of the Federal  
18 Driver Privacy Protection Act (DPPA, 18 U.S.C. Section 2721, et seq.) to conduct criminal

19 investigations for the Committee for Public Counsel Services (CPCS) or computer manufacturers  
20 or data processing consultants under contract with the commonwealth.
