By Ms. Walz of Boston, a petition (accompanied by bill, House, No. 306) of Martha M. Walz, Denise Andrews and Michael O. Moore for legislation to change the membership criteria of certain licensing boards. Consumer Protection and Professional Licensure.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act amending certain licensing board memberships.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to increase the capacity of vocational-technical programs, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 13 of chapter 13 of the General Laws, as appearing in the 2010  
2 Official Edition, is hereby amended by striking out, in line 1, the figure "17" and inserting in  
3 place thereof the following figure:- 19.

4 SECTION 2. Said section 13 of said chapter 13, as so appearing, is hereby further  
5 amended by striking out, in line 8, the words "112 and 2 consumers" and inserting in place  
6 thereof the following words:-

7 112; 3 consumers; and 1 vocational-technical licensed practical nursing educator or  
8 administrator who shall be selected from a group of 3 persons to be nominated by the  
9 Massachusetts Association of Vocational Administrators.

10 SECTION 3. Section 36 of said chapter 13, as so appearing, is hereby amended by  
11 striking out, in line 3, the word "nine" and inserting in place thereof the following figure:- 11.

12 SECTION 4. Said section 36 of said chapter 13, as so appearing, is hereby further  
13 amended by striking out, in line 5, the word "seven" and inserting in place thereof the following  
14 figure:- 9.

15 SECTION 5. Said section 36 of said chapter 13, as so appearing, is hereby amended by  
16 inserting, after the words "systems," in line 16, the following words:-

17 , 1 of whom shall be a vocational-technical plumbing educator or administrator who shall  
18 be selected from a group of 3 persons to be nominated by the Massachusetts Association of  
19 Vocational Administrators, 1 of whom shall be a licensed plumber in good standing who shall be  
20 selected from a group of 3 persons to be nominated by the Massachusetts Building Trades  
21 Council.

22 SECTION 6. Section 42 of said chapter 13, as so appearing, is hereby amended by  
23 striking out, in line 2, the word "seven" and inserting in place thereof the following figure:- 9.

24 SECTION 7. Said section 42 of said chapter 13, as so appearing, is hereby further  
25 amended by striking out, in line 5, the word "two" and inserting in place thereof the following  
26 figure:- 3.

27 SECTION 8. Said section 42 of said chapter 13, as so appearing, is hereby further  
28 amended by striking out, in line 6, the word "three" and inserting in place thereof the following  
29 figure:- 4.

30 SECTION 9. Said section 42 of said chapter 13, as so appearing, is hereby further  
31 amended by striking out, in line 35, the word "and".

32 SECTION 10. Said section 42 of said chapter 13, as so appearing, is hereby further  
33 amended by inserting after the word "cosmetology", in lines 36 and 37, the following words:-

34 ; (c) 1 member shall be a vocational-technical cosmetology educator or administrator who  
35 shall be selected from a group of 3 persons to be nominated by the Massachusetts Association of  
36 Vocational Administrators; and (d) 1 additional member.

37 SECTION 11. Section 101 of said chapter 13, as so appearing, is hereby amended by  
38 striking out, in line 4, the figure "5" and inserting in place thereof the following figure:- 7.

39 SECTION 12. Said section 101 of said chapter 13, as so appearing, is hereby further  
40 amended by inserting, after the word "work", in line 9, the following words:-

41 , 1 of whom shall be a vocational-technical sheet metal educator or administrator who  
42 shall be selected from a group of 3 persons to be nominated by the Massachusetts Association of  
43 Vocational Administrators, 1 of whom shall be a licensed sheet metal worker in good standing  
44 who shall be selected from a group of 3 persons to be nominated by the Massachusetts Building  
45 Trades Council.
