By Mr. Peterson of Grafton, a petition (accompanied by bill, House, No. 3266) of George N. Peterson, Jr. and others for legislation to prohibit counties, cities or towns from adopting ordinances or regulations concerning lawful firearms, ammunition or ammunition component rights. Public Safety and Homeland Security.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to constitutional rights.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 140 shall be amended by inserting the following section:-

2 Section 120A. No county, municipality, township or other community entity within the
3 Commonwealth of Massachusetts may enact, pass or enforce any law, ordinance or regulation
4 concerning the lawful ownership, use, possession, transfer, purchase, receipt or transportation of
5 firearms, antique firearms, ammunition or ammunition components.

6 The right to keep and bear arms as an individual civil right shall be presumed to exist in
7 all matters regarding the ownership, use, possession, transfer, purchase, receipt or transportation
8 of firearms, antique firearms, ammunition or ammunition components unless expressly
9 prohibited by the laws of this Commonwealth.
