**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act to increase transparency within campaigns.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 9 of chapter 55 of the General Laws, as appearing in the 2010  
2 Official Edition, is hereby amended by striking out, in line 4, the following words:- if the  
3 aggregate amount contributed in a calendar year exceeds \$50.

4 SECTION 2. Section 18 of chapter 55 of the General Laws, as appearing in the 2010  
5 Official Edition, is hereby amended by adding the following paragraph:- The office of campaign  
6 and political finance will prohibit political committees from expensing motor vehicles but shall  
7 allow mileage reimbursement.

8 SECTION 3. Chapter 159C of the General Laws, as appearing in the 2010 Official  
9 Edition, is hereby amended by adding the following section:-

10 Section 15. As used in this section, the following words shall, unless the context requires  
11 otherwise, have the following meanings:

12 "Robocall", is an automated phone call that uses both a computerized auto-dialer and a  
13 computer-delivered pre-recorded message.

14 "Robocall telephone solicitation", a voice or text communication, whether prerecorded or  
15 a facsimile, over a telephone line or wireless telephone network or via a commercial mobile  
16 radio service that is a robocall telephone solicitation to a telephone subscriber for the purpose of  
17 soliciting or encouraging the purchase or rental of, or investment in, property, goods, or services;  
18 obtaining or providing information that will or may be used for that purpose; soliciting or  
19 encouraging a telephone subscriber's participation in any contest, sweepstakes, raffle, or lottery,

20 whether legal or illegal; or obtaining a charitable donation. “Robocall telephone solicitation”  
21 shall include a political message if the message is communicated by use of an automatic dialing  
22 and recorded message player.

23 “Robocall telephone solicitor”, an individual, association, corporation, partnership,  
24 limited partnership, Limited Liability Company or other business entity, or a subsidiary or  
25 affiliate thereof, doing business in the commonwealth who makes or causes to be made a  
26 telephonic sales call.

27 Every political committee overseen by office of campaign and political finance will be  
28 required to disclose within a robocall who paid for the call.

29 SECTION 4. Subsection (a) of section 18A of chapter 55 of the General Laws, as  
30 appearing in the 2010 Official Edition, is hereby amended by adding the following paragraph:-  
31 All political organizations and committees conducting an independent expenditure exceeding  
32 \$1000 will be required to notify the office of campaign and political finance. The expenditure  
33 shall be disclosed within 5 days along with details on the expenditures and any donation 21 days  
34 prior to the expenditure.
