By Mr. Dwyer of Woburn, a petition (accompanied by bill, House, No. 377) of James J. Dwyer and others relative to school transportation. Education.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to school transportation.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 68 of chapter 71 of the General Laws is hereby amended by striking the section
2 in its entirety and inserting in place thereof the following section:

3 Section 68. Every town shall provide and maintain a sufficient number of schoolhouses,
4 properly furnished and conveniently situated for the accommodation of all children therein
5 entitled to attend the public schools. In determining eligibility for transportation, the school
6 committee shall consider including limits on the basis of attendance zones, zip codes or other
7 geographic subdivisions of the district. Nothing contained in the preceding sentence shall be
8 construed to limit the obligation of regional school districts to provide transportation for all
9 school children in grades kindergarten through twelve, pursuant to the provisions in section
10 sixteen C of this chapter. No school committee shall be compelled to furnish transportation on a
11 private way. In the case of transportation provided to students that is not required by this section
12 or by any other general or special law, a school committee may assess fees to the transported
13 student up to an amount sufficient to cover the costs incurred by the district; provided, however,
14 that no student eligible for free or reduced lunch, under the federal school lunch program, shall
15 be required to pay the fee; and provided further, that a school committee may choose to exempt
16 families at other income levels as it may determine. The school committee, unless the town
17 otherwise directs, shall have general charge and superintendence of the schoolhouses, shall keep
18 them in good order, and shall, at the expense of the town, procure a suitable place for the
19 schools, if there is no schoolhouse, and provide fuel and all other things necessary for the
20 comfort of the pupils. Each school shall comply with the requirements regarding pesticide
21 applications as set forth in sections 6C to 6I, inclusive, of chapter 132B. Whenever a town shall
22 undertake to provide a schoolhouse, the town shall appoint at least one member of the school

23 committee, or its designee, to serve on the agency, board or committee to which the planning and
24 construction or other acquisition of such schoolhouse is delegated.
