The Commonwealth of Massachusetts

In the Year Two Thousand Fourteen

An Act relative to junior operator's licenses.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The fifth paragraph of section 8 of chapter 90 of the General Laws, as
2 appearing in the 2012 Official Edition, is hereby amended by striking out the first sentence and
3 inserting in place thereof the following sentence:-

4 No person holding a junior operator's license shall operate a motor vehicle between the
5 hours of 12:30 a.m. and 5:00 a.m. unless the person is accompanied by a parent or legal guardian
6 or operating the vehicle as a means of access to or from an organized school event, including
7 athletic events, scheduled by the school, or an organization thereof, wherein the person is
8 actively enrolled as a student.
