By Representative Dykema of Holliston and Senator Spilka, a joint petition (accompanied by bill, House, No. 3961) of Carolyn C. Dykema and Karen E. Spilka (by vote of the town) that the town Holliston be authorized to establish a department of public works. Municipalities and Regional Government. [Local Approval Received.]

The Commonwealth of Massachusetts

In the Year Two Thousand Fourteen

An Act authorizing the town of Holliston to establish a department of public works.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. There is hereby established in the town of Holliston a department of public
2 works, which shall be under the supervision and control of the board of selectmen.

3 SECTION 2. Except as otherwise provided in this act, the board of selectmen of the
4 town of Holliston shall have all the powers and duties vested by general or special act or town
5 by-law in the following boards, commissions, departments or officers: highway department,
6 including the highway superintendent and the surveyors of highways; and the water department,
7 including the board of water commissioners. The board of water commissioners is hereby
8 abolished. No existing contract or liability in force on the effective date of this act shall be
9 affected, but the board shall in all respects be the lawful successor of the entity so abolished.

10 SECTION 3. The department of public works shall perform all the functions vested by
11 general or special law or town by-law in the following departments and offices: highway
12 department and water department. The department of public works shall assume the
13 responsibility for the operations of the streets and those functions of the park commission related
14 to management, care and maintenance of real property as the park commission may designate in
15 writing. All equipment, property, facilities, funds, assets and liabilities under the care, custody
16 and control of the abolished board of water commissioners on the effective date of this act, shall
17 be transferred to the care, custody and control of the board of selectmen. The provisions of
18 section 53F½ of chapter 44 of the General Laws shall apply to water related funds, assets and
19 liabilities, except as otherwise provided in this act.

20 SECTION 4. The town may provide, by town by-law, that the department of public
21 works have additional powers related to the following duties: the collection and disposal of
22 garbage and refuse; the maintenance and repair of street lights; the maintenance and repair of
23 town buildings and property other than buildings and property under control of the school
24 committee or the board of library trustees, unless said committee or board of trustees consent
25 thereto in writing; and the performance of such duties of any other boards, departments or offices
26 of the town as may be reasonably related to the duties of a department of public works.

27 SECTION 5. No later than 120 days prior to the beginning of each fiscal year, the board
28 of selectmen shall convene a public hearing to determine the water budget and set equitable
29 prices and rates for usage of the water system for the next fiscal year. The date, time and place
30 of the hearing shall be included in all water bills mailed for the second quarter of each fiscal
31 year. At least 2 weeks prior to the hearing, the board shall publish notice of the hearing in at
32 least 1 newspaper of general circulation in the town of Holliston, and post such notice at town
33 hall and on the town's Web site. At the hearing, the board of selectmen shall take testimony
34 from any interested party and shall then submit its recommendations to the town meeting, which
35 shall act upon the water budget in the same manner as all other budgets.

36 SECTION 6. Subject to appropriation and the provisions of the general town by-laws
37 and personnel by-laws, the board of selectmen shall appoint, fix the tenure and compensation of,
38 and enter into a contract with, a director of public works. The director shall exercise and
39 perform, in conformity with the policies of the board, those powers, rights and duties conferred
40 upon the board of selectmen pursuant to section 2 as said board may delegate. The director of
41 public works shall have full charge and authority over the employees, equipment and facilities
42 within the department of public words, subject to the requirements of any general or special law,
43 town by-laws, regulations and the direction and policies of the board of selectmen.

44 The director of public works shall, at a minimum, hold a bachelor's degree in civil
45 engineering or other appropriate discipline, and have at least 5 years of relevant professional
46 experience in public works construction and management. The board of selectmen may establish
47 other requirements such as registration as a professional civil engineer within the
48 commonwealth. During his or her tenure, the director of public works shall hold no other
49 elective or appointive office, nor shall the director of public works engage in any other business
50 or occupation without prior express written authorization of the board of selectmen. The director
51 of public works shall give the town a bond with a surety company authorized to transact business
52 in the commonwealth as surety for the faithful performance of his duties in such sum and upon
53 such conditions as the board of selectmen may require. The town shall pay the premium for said
54 bond.

56 The director of public works may designate, by letter approved by a vote of the board of
57 selectmen and filed with the town clerk, a qualified officer of the town to perform the director's
58 duties in the case of absence or disability. Pending the appointment of a director, the filling of
59 any vacancy, the failure of the director to designate a temporary director, or during the
60 suspension of the director, the board of selectmen shall appoint a suitable person to perform the
61 duties of the director's office.

62 SECTION 7. The director of public works shall appoint, remove and supervise
63 employees of the department of public works in accordance with the town's personnel by-law
64 and any applicable collective bargaining agreements. The director shall appoint and remove
65 such employees as the director deems necessary, subject to town meeting appropriation and
66 approval of the board of selectmen. The director of public works shall supervise, direct and be
67 responsible for the efficient administration of all departments, offices, boards and committees
68 appointed by the director.

69 The director of public works shall keep full and complete records of the department. The
70 director shall provide to the board of selectmen, as often as may be required by the board but at
71 least quarterly, a full report of all the operations under the director's control during the period
72 reported upon, and shall annually provide to the board and file with the town clerk a full report
73 of all the operations under the director's control, including, but not limited to: a full financial
74 report of all accounts, funds and grants; a work plan with related finance plan for the next fiscal
75 year, and a report on the accomplishments and progress made under the work plan from the
76 preceding fiscal year. The director of public works shall have access to all town books, records
77 and documents necessary for the proper performance of the assigned duties and responsibilities.

78 The director of public works shall keep the board of selectmen fully advised as to the
79 needs of the town within the scope of his duties, and shall annually, in conformity with the
80 requirements established by the board, provide to the board, in writing, a carefully prepared and
81 detailed budget and work plan including estimates of the appropriations and revenue for any
82 department enterprise funds established pursuant to section 53F $\frac{1}{2}$ of chapter 44 of the General
83 Laws required during the next fiscal year for the proper exercise and performance of all said
84 rights and duties.

85 The director of public works shall perform such other duties consistent with the office as
86 may be required by town by-laws, vote of town meeting, or majority vote of the board of
87 selectmen.

89 SECTION 8. The board of selectmen shall retain all powers, duties and responsibilities
90 associated with incurring debt.

91 SECTION 9. Once established, the town of Holliston may modify the duties, powers and
92 responsibilities of the department of public works. Integration of agencies, departments, or
93 districts not described in this act shall require approval by a majority vote at a town meeting.
94 Public works functions, once integrated, may be constituted as independent organizations or
95 departments by a majority vote at a town meeting.

96 SECTION 10. This act shall take effect upon its passage.
