An Act relative to the scheduling of high school athletic contests.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding the provisions of any general or special law to the  
2 contrary, the authorized representatives of school committees active in the selection,  
3 organization, scheduling and arranging of regular season and post-regular season interscholastic  
4 competitions or events, including, but not limited to, the Massachusetts Interscholastic Athletic  
5 Association, shall not schedule any competitions or events prior to 2:00 p.m. on the days on  
6 which either the SAT or ACT college entrance examinations are scheduled.

7           SECTION 2. This act shall take effect upon its passage.
