An Act to further the sharing of information by the Registry of Motor Vehicles.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1            Subsection (a) of section 22 of chapter 90 of the General Laws, as appearing in the 2012  
2 Official Edition, is hereby amended by adding at the end thereof the following sentence:-

4            Promptly following any suspension or revocation under this subsection, the registrar shall  
5 provide written notice to the police department of the municipality in which the licensee or  
6 registrant resides providing the name and address of the licensee or registrant, the license plate  
7 number of any vehicle registered to the operator at the time of the suspension or revocation, and  
8 the reasons for the suspension or revocation, accompanied by a copy of the operator’s driving  
9 record; provided, that the registrar shall promptly notify said police department following any  
10 reissuance of the license or registration.
