

HOUSE No. 4386

The Commonwealth of Massachusetts

In the Year Two Thousand Fourteen

An Act relative to simulcasting.

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to further regulate simulcasting, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The first paragraph of section 12A of chapter 494 of the acts of 1978 is

6 amended by striking out the words “July 31, 2014”, inserted by section 71 of said chapter 194,
7 and inserting in place thereof the following words:- July 31, 2016.

8 SECTION 3. The introductory paragraph of section 13 of said chapter 494 is hereby
9 amended by striking out the words “and until July 31, 2014”, inserted by section 72 of said
10 chapter 194, and inserting in place thereof the following words:- and until July 31, 2016.

11 SECTION 4. Section 15 of said chapter 494 is hereby amended by striking out the words
12 “and until July 31, 2014”, inserted by section 76 of said chapter 194, and inserting in place
13 thereof the following words:- and until July 31, 2016.

14 SECTION 5. The first paragraph of section 9 of chapter 277 of the acts of 1986 is hereby
15 amended by striking out the words “and until July 31, 2014”, inserted by section 77 of said
16 chapter 194, and inserting in place thereof the following words:- and until July 31, 2016.

17 SECTION 6. The first sentence of the first paragraph of section 3 of chapter 114 of the
18 acts of 1991 is hereby amended by striking out the words “and until July 31, 2014”, inserted by
19 section 78 of said chapter 194, and inserting in place thereof the following words:- and until July
20 31, 2016.

21 SECTION 7. The last paragraph of said section 3 of said chapter 114 is hereby amended
22 by striking out the words “July 31, 2014”, inserted by section 79 of said chapter 194, and
23 inserting in place thereof the following words:- July 31, 2016.

24 SECTION 8. The first paragraph of section 4 of said chapter 114 is hereby amended by
25 striking out the words “and until July 31, 2014”, inserted by section 80 of said chapter 194, and
26 inserting in place thereof the following words:- and until July 31, 2016.

27 SECTION 9. The last paragraph of said section 4 of said chapter 114 is hereby amended
28 by striking out the words “July 31, 2014”, inserted by section 81 of said chapter 194, and
29 inserting in place thereof the following words:- July 31, 2016.

30 SECTION 10. The first paragraph of section 5 of said chapter 114 is hereby amended by
31 striking out the words “and until July 31, 2014”, inserted by section 82 of said chapter 194, and
32 inserting in place thereof the following words:- and until July 31, 2016.

33 SECTION 11. Section 45 of chapter 139 of the acts of 2001 is hereby amended by
34 striking out the words “July 31, 2014”, inserted by section 84 of said chapter 194, and inserting
35 in place thereof the following words:- July 31, 2016.

36 SECTION 12. Section 20 of chapter 449 of the acts of 2006 is hereby amended by
