An Act relative to municipal election ballots.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 3 of chapter 55 of the General Laws, as appearing in the 2010
2 Official Edition, is hereby amended by inserting, after the words “or state,” in line 84, the
3 following words:- or municipal.

4 SECTION 2. Section 3 of chapter 55 of the General Laws, as so appearing, is hereby
5 amended by inserting, after the words “or state,” in line 91, the following words:- or municipal.
