An Act relative to an election laws implementation task force.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, there shall be  
2 established an election laws implementation task force.

3           (a) Said task force shall undertake a study of the implementation of An Act to Provide  
4 Audits of Elections Results as filed in the House in the 187th Session of the General Court as HB  
5 1980. Said study shall include, but not be limited to, an analysis of: (1) the state and local costs  
6 of implementing said proposal, and the availability of federal funding through the Help America  
7 Vote Act; (2) the administrative requirements for adopting such a proposal, including the impact  
8 upon poll operations and upon the operation of municipal clerks' offices on election day; (3) the  
9 possibility of fraud; and (4) the effects upon finalizing a vote and possible recounts.

10           (b) The task force shall complete its study and submit its final report in writing to the  
11 joint committee on election laws and the state secretary no later than July 31, 2014.

12           (c) The task force shall consist of the house and senate chairs of the joint committee on  
13 election laws, the speaker of the house of representatives or his designee, the president of the  
14 senate or her designee, the house minority leader or his designee, the senate minority leader or  
15 his designee, the state secretary or his designee, the chairs of the house and the senate ways &  
16 means committees or their designees, the state auditor or his designee, the director of the office  
17 on disability or her designee, two (2) representatives of the Massachusetts Town Clerks'  
18 Association, at least one (1) of whom shall be a town clerk of a town of fewer than 10,000  
19 inhabitants, two (2) representatives of the Massachusetts City Clerks Association at least one (1)  
20 of whom shall be a clerk of a municipality of fewer than 60,000 inhabitants, and one (1)

21 representative of each of the following groups: the Massachusetts Municipal Association, the  
22 League of Women Voters of Massachusetts, the Massachusetts Chapter of the NAACP,  
23 Common Cause, and MassVOTE.

24 SECTION 2: This act shall take effect upon passage.
