An Act to place photo identification on EBT cards.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 18 of the General Laws, as amended by Section 3 of Chapter 161  
2 of the Acts of 2012, is hereby amended by inserting after section 5N the following new section :-

3           “Section 5O: Notwithstanding any general or special law to the contrary, effective six  
4 months following the passage of this section, the department shall include on the front of each  
5 newly issued and re-issued electronic benefit transfer card, a photograph of the cardholder.  
6 Effective twelve months following the passage of this section, the department shall replace all  
7 existing electronic benefit transfer cards with cards containing a photograph of the cardholder.”
