An Act to repeal the 2013 sales tax on computer and software technology services.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding the provisions of any general or special law to the  
2 contrary, “Computer system design services,” as defined in section 1 of chapter 64H of the  
3 General Laws, and services consisting of the modification, integration, enhancement, installation  
4 or configuration of standardized software, shall be exempt from any excise, sales, or use tax  
5 imposed by chapter 64H or chapter 64I of the General Laws.

6           SECTION 2. This Act shall take effect beginning July 31, 2013.
