An Act authorizing the commissioner of Capital Asset Management and Maintenance to grant easements over certain parcels of land to the town of Amherst.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to grant forthwith easements over certain parcels of land to the town of Amherst, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding sections 40E to 40J, inclusive, of chapter 7 of the General  
2 Laws or any other general or special law or rule or regulation to the contrary, the commissioner  
3 of capital asset management and maintenance, in consultation with the University of  
4 Massachusetts at Amherst, may grant to the town of Amherst, and the town of Amherst may  
5 acquire, a permanent sewer easement on a portion of land located in the town of Amherst and  
6 described in a deed recorded with the Hampshire Registry of Deeds in book 1600, page 720, a  
7 confirmatory permanent public way and utility easement on a parcel of land known as Olympia  
8 Drive, and a permanent water and sewer easement on a parcel of land known as Authority Way,  
9 all as described on a plan of land entitled “Roadway Acceptance Plan Olympia Drive and  
10 Authority Way, Amherst, MA” dated August 23, 2012, prepared by Doucet & Associates, Inc.

11           SECTION 2. In consideration for the grant of easements, the town of Amherst shall, upon  
12 acceptance of Olympia Drive as a public way, repair and maintain said public way in the same  
13 manner in which other public ways are maintained in the town of Amherst, including, but not  
14 limited to, roadway resurfacing, substrate and pavement repair, cleanup and snow removal.

15           SECTION 3. The town of Amherst shall be responsible for all costs and expenses  
16 including, but not limited to, costs associated with any engineering, surveys and document  
17 preparation related to the grant of easements authorized in section 1 of this act as such costs may  
18 be determined by the commissioner.
