An Act authorizing the division of capital asset management and maintenance to convey certain property at Northampton State Hospital.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith the conveyance of a certain parcel of land at Northampton State Hospital, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Pursuant to chapter 86 of the acts of 1994, the Commonwealth of  
2 Massachusetts, acting through the division of capital planning and operations, conveyed portions  
3 of the Northampton State Hospital to Hospital Hill Development LLC, a Delaware limited  
4 liability company, c/o Massachusetts Development Finance Agency, 160 Federal Street, Boston,  
5 Massachusetts 02110, for the redevelopment of such portions of the Northampton State Hospital  
6 in accordance with chapter 86 of the acts of 1994. The division of capital planning and  
7 operations is now named the division of capital asset management and maintenance.

8           SECTION 2. Notwithstanding sections 40E to 40J, inclusive, of chapter 7 of the General  
9 Laws or any other general or special law to the contrary, pursuant to the express authority in  
10 chapter 86 of the acts of 1994, the commissioner of capital asset management and maintenance,  
11 in consultation with the commissioner of mental health, is hereby authorized to convey by deed,  
12 or to lease for a period not to exceed ninety-nine years, to Hospital Hill Development LLC, for  
13 nominal consideration that certain parcel of land comprising a part of the Northampton State  
14 Hospital located on the parcel known as the "Haskell Building Parcel" and comprising  
15 approximately 18,000 square feet as shown on a plan dated April 3,2012 and prepared by

16 Arrowstreet Architects and held in the offices of the division of capital asset management and  
17 maintenance. The exact size and boundaries of the land to be conveyed shall be determined by  
18 the commissioner of capital asset management and maintenance, in consultation with the  
19 secretary of health and human services, the commissioner of mental health and Hospital Hill  
20 Development LLC, after completion of a survey.

21 SECTION 3. The commissioner of capital asset management and maintenance, acting in  
22 consultation with the commissioner of the department of mental health, shall prepare the  
23 necessary documents to convey the property described in section 2 to Hospital Hill Development  
24 LLC. Hospital Hill Development LLC shall be responsible for all costs including, without  
25 limitation, recording fees, to effect the transactions contemplated by section 2.

26 SECTION 4. This act shall take effect upon its passage.
