Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the licensing authority of the city of Taunton may grant up to 2 additional licenses for the sale of all alcoholic beverages not to be drunk on the premises under section 15 of said chapter 138. A license issued under this subsection shall be subject to all of said chapter 138 except said section 17.
- (b) Notwithstanding section 17 of chapter 138 of the General Laws, the licensing authority of the city of Taunton may grant up to 2 additional licenses for the sale of wines and malt beverages not to be drunk on the premises under section 15 of said chapter 138. A license issued under this subsection shall be subject to all of said chapter 138 except said section 17.
- (c) The licensing authority shall not approve the transfer of a license granted under this act to any other person, partnership, corporation, limited liability company, organization or other entity for 3 years from the date of original issuance. No license to be transferred under this act shall be approved unless the applicant files with the licensing authority a letter from the department of revenue and a letter from the division of unemployment assistance indicating that the license is in good standing with those entities and that all applicable taxes, fees and contributions have been paid.
- (d) If a license granted under this section is revoked, cancelled or no longer in use, it shall be returned physically with all of the legal rights and privileges pertaining thereto to the

- licensing authority which may then grant the license to a new applicant at the same location

- 21 SECTION 2. This act shall take effect upon its passage.
