

The Commonwealth of Massachusetts

1 SECTION 1. To provide for a program of transportation development and improvements,
2 the sums set forth in sections 2 to 2G, inclusive, for the several purposes and subject to the
3 conditions specified in this act, are hereby made available, subject to the laws regulating the
4 disbursement of public funds. The sums appropriated in this act shall be in addition to any
5 amounts previously appropriated and made available for these purposes.

9 6121-1314 For projects on the interstate and non-interstate federal highway system;
10 provided, that funds may be expended for the costs of these projects including, but not limited to,
11 the nonparticipating portions of these projects and the costs of engineering and other services
12 essential to these projects; provided further, that notwithstanding this act or any other general or
13 special law to the contrary, the department shall not enter into any obligations for projects which
14 are eligible to receive federal funds under this act unless state matching funds exist which have
15 been specifically authorized and are sufficient to fully fund the corresponding state portion of the
16 federal commitment to fund these obligations; and provided further, that the department shall
17 only enter into obligations for projects under this act based upon a prior or anticipated future
18 commitment of federal funds and the availability of corresponding state funding authorized and
19 appropriated for this use by the general court for the class and category of project for which this
20 obligation applies \$1,900,000,000

24 6121-1317 For the design, construction and repair of, or improvements to, non-federally-
25 aided roadway and bridge projects and for the nonparticipating portion of federally-aided

26 projects; provided, that the department may use these funds for the purchase and rehabilitation of
27 facilities, heavy equipment and other maintenance equipment; provided further, that the amounts
28 specified in this item for a particular project or use may be adjusted in order to facilitate other
29 projects relating to the design, construction, repair or improvement to non-federally-aided
30 roadway projects; provided further, that \$377,255,000 shall be expended for the design,
31 construction and repair of, or improvements to, pedestrian, bicycle and multi-use pathways;
32 provided further, provided further, that \$5,000,000 shall be expended for design, construction,
33 repair, or improvements to pedestrian, bicycle, and public parking areas, and multi-use pathways
34 in Chelmsford Center in the town of Chelmsford; provided further, that \$156,000 shall be
35 expended for the installation of a wireless coordination system for 39 identified traffic signals in
36 Waltham; provided further, that \$4,500,000 shall be expended to replace Sherman's bridge
37 connecting the town of Sudbury and the town of Wayland; provided further, that no less than
38 \$5,000,000 shall be expended on an analysis of transit capacity issues in Greater Boston,
39 including recommendations and preliminary engineering for addressing these challenges;
40 provided further, that \$500,000 shall be expended for design and permitting to improve safety,
41 bus prioritization, and accessibility at the intersection of Fresh Pond parkway and Mount Auburn
42 street in the city of Cambridge; provided further, that \$1,300,000 shall be expended for
43 construction of Phase II of the Watertown Greenway multi-use path from Arlington street in the
44 town of Watertown to Fresh Pond Reservation in the city of Cambridge; provided further, that
45 \$1,520,000 shall be expended for construction and oversight of the reconstruction of Belmont
46 Center in Belmont; provided further, that \$10,000,000 shall be expended for the redevelopment
47 of the Springfield union station in the city of Springfield; provided further, that \$3,000,000 shall
48 be expended for a pedestrian walkway and bike path along the Connecticut river in the city of
49 Springfield; provided further that \$3,000,000 shall be expended for improvements to the Gerena
50 School tunnel in the city of Springfield; provided further, that \$205,273 shall be expended to
51 repair a roadway shoulder failure across from 325 Worcester Street in the Town of West
52 Boylston; provided further that \$1,000,000 shall be expended for improvements to Tronic
53 square, including traffic signals, traffic mitigation, and lighting in the city of Worcester; provided
54 further, that \$1,000,000 shall be expended for the sewer expansion project along route 20,
55 between Massasoit road and Sunderland road, in the city of Worcester; provided further, that not
56 less than \$2,300,000 shall be expended for construction on route 140 between the Sterling town
57 line and East Princeton Village; provided further, that \$500,000 shall be expended to make
58 Newton Highlands Station located along the green line in the city of Newton fully accessible,
59 including but not limited to, the design and construction of a path of travel from the street level
60 to the station; provided further, that \$1,500,000 shall be expended to raise the station platform at
61 Newton Highlands Station located along the green line in the city of Newton approximately 8
62 inches to accommodate low car trains; provided further, that \$420,000 be expended for the
63 reconstruction of Babcock street from Devotion street to Commonwealth avenue in Brookline;
64 provided further, that not less than \$200,000 shall be expended to delead and repaint the bridge
65 on Cliff Road over the railroad tracks in the town of Wellesley; provided further, that \$1,000,000

66 shall be expended for the planning, design, construction, and any other associated costs for
67 transportation improvements at the intersection of route 9 (Worcester street) and Kingsbury
68 street in the town of Wellesley; provided further, that \$5,000,000 shall be expended for the
69 design and reconstruction of Brattle and Eliot Streets in the Harvard Square neighborhood in the
70 city of Cambridge; provided further, that \$3,500,000 shall be expended for the reconstruction of
71 Beacham Street in the city of Everett; provided further, that \$1,000,00 shall be allocated for
72 infrastructure improvement to the Maurice J. Tobin Memorial Bridge in the city of Chelsea and
73 the Charlestown section of the city of Boston, including but not limited to guardrail and lighting
74 repairs; provided further, that \$250,000 shall be expended for a study on the feasibility of a
75 commuter rail stop in the city of Everett; provided further, that \$500,000 shall be expended for
76 street and sidewalk resurfacing on Pleasant street in Arlington; provided further, that \$1,500,000
77 shall be expended for the reconstruction of Gray street and sidewalks in the town of Arlington;
78 provided further, that \$50,000 shall be expended for an engineering study to examine the
79 feasibility of reconstructing the intersection of interstate 95 and route 3 in the town of
80 Burlington; provided further, that \$5,000,000 shall be expended for environmental permitting,
81 alternatives analysis, type-study, and design for a permanent replacement for the Rourke Bridge
82 in the City of Lowell; provided further, that \$725,000 shall be expended for the replacement of
83 the Beaver Brook Bridge located on Beaver Brook Road in the town of Westford; provided
84 further, that \$1,000,000 shall be expended for the design, construction, right-of-way assembly,
85 and related project costs for the realignment of Tanner Street, in support of the Ayer's City Plan,
86 in the City of Lowell; provided further, that not less than \$6,000,000 shall be expended for the
87 replacement of a parking garage between Columbus street and Summer street in the city of
88 Pittsfield; provided further, that not less than \$1,500,000 shall be expended for the repair of the
89 Brown street bridge in the city of North Adams; provided further, that \$750,000 shall be
90 expended for the repair of the Route 7 bridge that spans the Housatonic River in the town of
91 Great Barrington; provided further, that \$1,750,000 shall be expended for roadway and utility
92 improvements on Thiel road in the town of Adams; provided further, that not less than
93 \$5,000,000 shall be expended to advance the permitting and design of the Reconstruction of I-
94 290 and I-495 Interchange and Bridge Replacement in the Town of Hudson and City of
95 Marlborough; provided further, that \$4,000,000 shall be expended for the downtown
96 revitalization, complete streets, traffic management reconstruction of Main and South Streets in
97 the town of Hudson; provided further, that \$300,000 shall be expended for the study, design,
98 planning and construction of intersection improvements at the intersection of route 27 and
99 Concord street in the town of Maynard; provided further, that not less than \$10,000,000 shall be
100 expended for the design and reconstruction of Route 38 from Pleasant Street to Shawsheen Street
101 in the town of Tewksbury; provided further, that \$2,500,000 shall be expended for the
102 reconstruction of Water Street from Bemis Road to Laurel Street, in the city of Fitchburg;
103 provided further, that not less than \$1,169,000, shall be expended for the reconstruction and
104 improvement of Route 140 from Green Street to the Winchendon town line, in the town of
105 Gardner; provided further, not less than \$6,031,000 shall be expended for acquisition and

106 construction cost of the Twin Cities Rail Trail in the cities of Fitchburg and Leominster;
107 provided further, \$300,000 shall be expended for construction of improvements to Boulder Drive
108 for sidewalks, paving, traffic calming, parking and streetscape improvements per the city's Main
109 Street Improvement Plan, in the City of Fitchburg; provided, further that \$4,200,000 shall be
110 expended for improvements to 11 priority intersections in the neighborhoods of Dorchester,
111 South End, East Boston, Mattapan, and Roxbury in the city of Boston; provided, further that
112 \$500,000 shall be expended for beautification and streetscape improvements to Mattapan Square
113 including, but not limited to, the planting of trees in the median of Blue Hill Avenue from
114 Mattapan square to Woodhaven street, the repainting of traffic lines and bicycle lanes on Blue
115 Hill Avenue from Mattapan square to Walk Hill street, and the repainting of Mattapan square
116 business district parking spaces in the Mattapan section of the city of Boston; provided further,
117 that \$100,000 shall be expended for the installation of three additional MBTA Bus Shelters one
118 at the intersection of Cummins highway and River street and two on Blue Hill avenue in
119 Mattapan square in the Mattapan section of the city of Boston; provided further, that \$750,000
120 shall be expended for resurfacing of the Neponset Valley parkway in the city of Boston;
121 provided further, that not less than \$6,925,000 shall be expended for safety, drainage and traffic
122 flow improvements on Route 3A, Summer Street, and Rockland Street, including consideration
123 of pedestrian and bicycle traffic, in the towns of Hingham and Hull; provided further, that not
124 less than \$3,075,000 shall be expended on safety improvements to Route 3A, from the MBTA
125 commuter rail station in Cohasset to Henry Turner Bailey Road in Scituate, consistent with the
126 recommendations of Boston Region MPO's Route 3A Subregional Priority Roadway Study, and
127 comments from officials in the towns of Cohasset and Scituate; provided further, that \$2,000,000
128 shall be expended for the emergency repair of the East street bridge in the town of Southampton;
129 provided further, that \$1,000,000 shall be expended for the emergency repair of Carrington road
130 in the towns of Russell and Montgomery; provided further, that \$900,000 shall be expended for
131 the reconstruction of portions of Fomer and Russellville roads in the town of Southampton;
132 provided further, that \$800,000 shall be expended for the emergency repair of the Powder Mill
133 Brook bridge on Main road in the town of Montgomery; provided further, that \$7,500,000 shall
134 be expended for the construction of a parking garage in Medford square in the city of Medford;
135 provided further, that \$75,000 shall be expended for pedestrian safety improvements on route 16
136 in the vicinity of Dilboy Stadium in the city of Somerville; provided further, that \$500,000 shall
137 be expended for design and permitting to improve safety, bus prioritization, and accessibility at
138 the intersection of Fresh Pond parkway and Mount Auburn street in the city of Cambridge;
139 provided further, that \$500,000 shall be expended for the repair and rehabilitation of the bridge
140 across the Aberjona river on Mount Vernon street in the town of Winchester; provided further,
141 that \$1,200,000, shall be expended for improvements to the intersection of Sea street and Quincy
142 Shore drive in the city of Quincy; provided further, that \$800,000 shall be expended to expand
143 the state owned Commander Shea boulevard into Squantum Point Park to open access for
144 establishing a ferry service in the interest of transportation and tourism in the city of Quincy;
145 provided further, that \$3,800,000 shall be expended for the design and reconstruction at the

146 intersection of Crecsent street, Route 27, Quincy street and Massasoit Boulevard in the city of
147 Brockton; provided further, that \$1,500,000 shall be expended for the design and reconstruction
148 of North Quincy Street, Chestnut Street and Boundry Avenue, in the city of Brockton; provided
149 further, that \$1,650,000 shall be expended for signalization and intersection improvements on
150 Route 27 at the intersection of South Ave and Franklin Street, in the town of Whitman; provided
151 further, that \$2,000,000 shall be expended for the design and reconstruction of sidewalk and
152 roadway improvements on Route 18 from Whitman Street to Central Street, in the town of East
153 Bridgewater; provided further, that \$100,000 shall be expended for an engineering study to
154 review traffic intersections in and around the North Beverly train station, including Laurel,
155 Dodge and Enon Streets, and recommend improvements to address traffic issues in the city of
156 Beverly; provided further, that \$950,000 shall be expended to complete the resurfacing and
157 related work required to install a new surface wearing course of asphalt pavement on route 97 in
158 the town of Topsfield; provided further, that \$500,000 shall be expended for the repair and
159 reconstruction for the culvert located on Route 22 in the town of Wenham; provided further, that
160 \$3,000,000 shall be expended for the sewer expansion project along route 20, between Massasoit
161 road and Sunderland road, in the city of Worcester; provided further, that \$400,000 shall be
162 expended for the reconstruction of ADA accessible sidewalks in the downtown area of the town
163 of Millbury; provided further, that \$625,000 shall be expended for the design of the commercial
164 gateway from Snow Road and Carroll Road to historic downtown in the town of Grafton;
165 provided further, that \$100,000 shall be expended to demolish and remove asbestos from a house
166 on DPW property in the town of Millbury; provided further, that \$500,000 shall be expended for
167 a study to examine the cost and feasibility of using current commuter rail infrastructure for the
168 Massachusetts Bay Transit Authority’s Blue Line connecting in revere and continuing to run
169 along the tracks into the Lynn Station; provided further, that \$4,000,000 shall be expended
170 towards the design of the Malden-Revere-Saugus Reconstruction and Widening Project on Route
171 1, from Route 60 to Route 99 and shall include a feasibility study of connecting the city of Lynn
172 to Route 1 in Revere; provided further, that \$4,400,000 shall be expended for the replacement of
173 3500 linear feet of drain pipe on Paradise Road between Franklin Avenue and Stacy’s Brook in
174 Swampscott; provided further, that \$900,000 shall be expended for the replacement of 4200
175 linear feet of 8” iron water main with 12” PVC pipe, and road improvements in the town of
176 Marblehead; Provided further, that \$408,000 shall be expended for stabilization and
177 reconstruction improvements of Tudor Wharf in the town of Nahant; provided further, that
178 \$220,000 shall be expended for the dredging of Lynn Harbor, in the city of Lynn; provided
179 further, that \$1,000,000 shall be expended for the Mt. Vernon Street Viaduct repairs in the city of
180 Lynn; provided further that \$840,000 shall be expended for infrastructure improvements at the
181 intersection of Pleasant Street, Village Street and Vine Street in the town of Marblehead;
182 provided further, that \$100,000 shall be expended for a study of the Route 107 and Route 129
183 intersections at Eastern and Western Avenue and Stanwood Street and Waitt Ave and Maple
184 Street in the city of Lynn; provided further, that \$750,000 shall be expended for the
185 reconstruction of the Wyoma parking facility off Route 129 in the city of Lynn; provided further,

186 that \$1,000,000 shall be expended for the construction of a pedestrian overpass on Route 1A on
187 the Lynnway at Blossom Street in the city of Lynn; Provided further, that \$495,000 shall be
188 expended for transit access enhancements and roadway and streetscape improvements on the
189 Washington Street Smart Growth corridor in the cities of Melrose and Malden; provided further,
190 that \$985,000 shall be expended for traffic mitigation and construction of pedestrian-oriented
191 street layouts, center island, bicycle pathways, lighting and sidewalk improvements to Main
192 Street in the town of Wakefield; provided further, that \$ 5,000,000 shall be expended to create
193 road and rail access to the New Bedford Marine Commerce Terminal along MacArthur Drive in
194 the city of New Bedford; provided further, that \$5,000,000 shall be expended to improve Route
195 18 south of Walnut street intersecting streets, which shall include boulevard improvements to car
196 and pedestrian access across the highway to the waterfront, in the city of New Bedford; provided
197 further, that \$6,000,000 shall be expended for the construction of an intermodal transportation
198 center and parking garage in the town of Plymouth; provided further, that \$100,000 shall be
199 expended for the repair and construction of a bridge to allow handicapped access and for the
200 installation of a fish ladder at Herring Run Park in the town of Pembroke; provided further, that
201 \$75,000 shall be expended for Buzzards Bay train station ADA compliance cost study within the
202 town of Bourne; provided that not less than \$290,000 shall be expended for roadway
203 improvements to Brick Kiln Road from Route 28A to Town Line East of Service Road including
204 3" asphalt milling and overlay of approximately 2,700' of 35' wide pavement, loam/seeding and
205 incidental items, in the town of Falmouth; provided further, that not less than \$1,500,000 shall be
206 expended for the Route 95 Ghost Rail Trail Route 95 underpass connector from Rabbit Road in
207 the town of Salisbury to Elm Street in the city of Amesbury; provided further, that not less than
208 \$500,000 shall be expended for the design and public safety improvements from the intersection
209 of Burnham Road and State Highway Routes 110/113 to the intersection of Haverhill and
210 Woodland Streets in the city of Methuen; provided further, that not less than \$5,000,000 shall be
211 expended for the regional intercity bus and intermodal parking facility for the Merrimack Valley
212 Regional Transportation Authority (MVRTA), provided however, funding for this project shall
213 not reduce funding provided in this item for mobility assistance programs under section 13 of
214 chapter 637 of the acts of 1983, in the city of Newburyport; provided further, that \$1,500,000
215 shall be expended for improvements along Route 114 in North Andover from the Lawrence
216 municipal boundary to the intersection of Route 114, Mill Street, and Willow Street, including
217 the widening at the Shawsheen River Bridge and Hillside Avenue and recommendations
218 included in the Road Safety Audit prepared for MassDOT in the town of North Andover;
219 provided further, that \$750,000 shall be expended for the reconstruction of sidewalks on High
220 street, to meet ADA compliance, in the city of Taunton; provided further, that \$550,000 shall be
221 expended for the Oak street bridge in the town of Bridgewater; provided further, that \$80,000
222 shall be expended for the initial design and permit scoping for a commuter rail station in the
223 town of Wareham; provided further, that \$20,000 shall be expended for the design and
224 fabrication of way- finding and welcome signs for the town of Middleborough; provided further,
225 that \$7,150,000 shall be expended for the design and construction of a commuter rail station at

226 Wonderland Park on the Newburyport/Rockport line in the city of Revere, together with design
227 and construction of an enclosed pedestrian connection to the Wonderland Station intermodal
228 transit facility on the Blue Line in the city of Revere; provided further, that not less than
229 \$500,000 shall be expended to create a scenic pedestrian and bicycle pathway from Main Street
230 in the town of Winthrop at Belle Isle Marsh to Short Beach in the city of Revere; provided
231 further, that not less than \$2,250,000 shall be expended for Winthrop Street Corridor
232 improvements including road and infrastructure improvements from Washington Avenue to
233 Banks Street and reconstruction and traffic realignment of McGee's Corner in the town of
234 Winthrop; provided further, that not less than \$100,000 shall be for the purpose of studying the
235 costs as well as the economic, cultural and recreational benefits of creating a public marina at the
236 dock located between the Steriti Memorial Skating Rink and the Prince Street Park on
237 Commercial Street, and the feasibility of including a water taxi station for the use of the
238 Massachusetts Bay Transit Authority, in the city of Boston; provided further, that \$5,590,000
239 shall be expended for the repair and renovation of the Blackstone Canal, in the town of

244 Oxford Avenue in the town of Dudley; provided further, that \$400,000 shall be expended for the
245 removal of debris and structures of the old Hix bridge on the east branch of the Westport river in
246 the town of Westport; provided further, that \$175,000 shall be expended to upgrade and create a
247 scenic pedestrian riverwalk and bicycle lane along Riverside Avenue from the Buffinton Street
248 intersection to the South Street intersection in the town of Somerset; provided further, that
249 \$500,000 shall be expended for the planning, design, and installation of lighting on the Charles
250 M. Braga, Jr. Memorial Bridge in the city of Fall River; provided further, that \$2,000,000 shall
251 be expended to reconfigure the Bark street/Stevens street intersection through the use of a
252 roundabout in the town of Swansea; provided further, \$5,000,000 shall be expended for the
253 development of a parking garage downtown in the city of Greenfield; provided further, that not
254 less than \$3,200,000 shall be expended for the repair of Winchester Road in the town of
255 Warwick; provided further, that not less than \$1,550,000 shall be expended for safety
256 improvements at the intersection of New South street, Main street, Elm street and State street in
257 the city of Northampton; provided further, that \$4,000,000 shall be expended for roadway
258 reconstruction, widening, and sidewalk installation on Taunton Street from Common Street near
259 Route 1A to a point approximately .8 miles south in the town of Wrentham; provided further,
260 that \$4,003,000 shall be expended for the construction of ramps at the interchange of Route 1A
261 and I-495 in the town of Wrentham; provided further, that \$500,000 shall be expended to study
262 the replacement of the Main street bridge and the Lawrence street bridge in the town of Norfolk;
263 provided further that \$3,000,000 shall be expended for improvements and maintenance of the
264 VFW Parkway in the West Roxbury section of the city of Boston; provided further, that
265 \$5,000,000 shall be expended for improvements to the Marine Corps rotary and Veterans of

266 Foreign Wars parkway in the town of Dedham; provided further, that not less than \$1,500,000
267 shall be expended for the reconstruction of Nahatan St. to Route 1A in the town of Norwood;
268 provided further, that \$2,000,000 shall be expended for the planning, design and reconstruction
269 of the Route 126 corridor in the town of Ashland; provided further, that not less than \$5,000,000
270 shall be expended for the planning, engineering, design, or construction of projects to mitigate
271 the impact of CSX and MBTA rail operations the at-grade rail crossings at the intersections of
272 route 126, route 135, Bishop Street in the town of Framingham; provided further, that not less
273 than \$2,000,000 shall be expended for the planning, engineering, design, or construction of
274 projects to mitigate the impact of the at-grade rail crossing, including the impact on the delivery
275 of emergency municipal services, including police and fire services, in the town of Ashland;
276 provided further, that not less than \$1,000,000 shall be expended for planning, design, and
277 construction related to improvements to Route 109 in the town of Medway; provided that
278 \$3,000,000 shall be expended for pavement reconstruction, consisting of full depth reclamation,
279 with some cold-planning and resurfacing at the side streets and project limits, ADA compliant
280 sidewalk reconstruction and handicap ramps, granite curbing, drainage improvements,
281 landscaping/roadside development improvements, flashing warning beacon at the intersection of
282 Washington Street and Centennial drive, and signs and pavements markings to Washington street
283 from Grant Circle to Mansfield street in the City of Gloucester; provided that \$1,500,000 shall be
284 expended for the construction of a downtown boardwalk in the town of Essex; provided further
285 that \$1,000,000 shall be expended to repair the drainage system between Routes 128 and 127 in
286 the town of Manchester-by-the Sea; provided further, that \$120,000 shall be expended for an
287 emergency access road to and from Plum Island in the town of Newbury; provided further, that
288 \$2,000,000 shall be expended for the study, design, and construction as dated for the traffic light
289 fixture at route 44 (Winthrop Street) and route 118 (Bay State Road) within the town of
290 Rehoboth; provided further, that \$750,000 shall be expended for traffic signalization at the
291 intersection of Route 123 and Route 495 in the town of Norton; provided further, that not less
292 than \$150,000 shall be expended for an emergency traffic light at the public safety building on
293 Taunton Avenue in the town of Seekonk; provided further, that \$500,000 shall be expended for
294 the design and engineering of the Norton rail trail bicycle path within the town of Norton;
295 Provided further, that \$3,000,000 shall be expended for the design, reconstruction and safety
296 improvements to Memorial Avenue in the town of West Springfield; provided further, that not
297 more than \$200,000 shall be expended for traffic and parking issues as they pertain to the current
298 “Park & Ride” facility at exit 6 off Route 6 for the Town of Barnstable, and the feasibility to
299 expand the current facility or build a new Park & Ride facility for the town of Barnstable;
300 provided further, that \$5,000,000 shall be expended on sidewalk construction and upgrades so
301 that they be ADA compliant for the town of Yarmouth; provided further, that \$2,000,000 shall be
302 expended for the Parkers River Bridge improvements to improve the design of the bridge to
303 allow for pedestrian access under the bridge and increase elevation for the Town of Yarmouth;
304 provided further, that up to \$10,000,000 shall be expended, or transferred directly to the town of
305 Milton, for improvements to the DCR Blue Hills Parkway in Milton; provided further, that up to

306 \$10,000,000 shall be expended on design, road reconstruction, aesthetic improvements,

657 regulations, exercise all powers and do all things necessary and convenient to carry out the
658 purposes of this act.

659 (d) In carrying out this section, the Massachusetts Department of Transportation may
660 enter into contracts or agreements with cities to mitigate the effects of projects undertaken
661 pursuant to this act and to undertake additional transportation measures within the city and may
662 enter into contracts, agreements or transactions with other federal, state, local or regional public
663 agencies, authorities, nonprofit organizations or political subdivisions that may be necessary to
664 implement these contracts or agreements with cities. Cities and other state, local or regional
665 public agencies, authorities, nonprofit organizations or political subdivisions may enter into these
666 contracts, agreements or transactions with the department. In relation to these agreements, the

667 department may advance to these agencies, organizations or authorities, without prior
668 expenditure by the agencies, organizations or authorities, monies necessary to carry out these
669 agreements, but the department shall certify to the comptroller the amount so advanced, and all
670 monies not expended under these agreements shall be credited to the account of the department
671 from which they were advanced. The department shall report to the house and senate committees
672 on ways and means on any transfers completed pursuant to this subsection.

673 SECTION 17. Notwithstanding any other general or special law to the contrary, the
674 Massachusetts Department of Transportation shall take all necessary actions to secure federal
675 highway or transportation assistance that is or may become available to the department
676 including, but not limited to, actions authorized pursuant to or in compliance with any of the
677 following: Title 23 of the United States Code; the Surface Transportation and Uniform
678 Relocation Act of 1987, Public Law 100-17; the Intermodal Surface Transportation Efficiency
679 Act of 1991, Public Law 102-240; the Transportation Equity Act for the 21st Century, Public
680 Law 105-178; the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy
681 for Users, Public Law 109-59; Implementing Recommendations of the 9/11 Commission Act of
682 2007, Public Law 110-53; and any successor or reauthorizations of said acts, and actions such as
683 filing applications for federal assistance, supervising the expenditure of funds under federal
684 grants or other assistance agreements and making any determinations and certifications
685 necessary or appropriate to the foregoing. If a federal law, administrative regulation or practice
686 requires an action relating to federal assistance to be taken by a department, agency or other
687 instrumentality of the commonwealth other than the Massachusetts Department of
688 Transportation, the other department, agency or instrumentality shall take such action.

689 SECTION 18. Notwithstanding any other general or special law to the contrary, all
690 construction contracts funded in whole or in part by the funds authorized by this act shall include
691 a price adjustment clause for each of the following: fuel, both diesel and gasoline, asphalt,
692 concrete and steel. A base price for each material shall be set by the awarding authority or
693 agency and included in the bid documents at the time a project is advertised. The awarding
694 authority or agency shall also identify in the bid documents the price index to be used for each
695 material or supply. The adjustment clause shall provide for a contract adjustment to be made on a
696 monthly basis when the monthly cost change exceeds plus or minus 5 per cent.

697 SECTION 19. Notwithstanding any other general or special law to the contrary, section
698 61 and sections 62A to 62I, inclusive, of chapter 30, chapter 91 and section 40 of chapter 131 of
699 the General Laws shall not apply to bridge projects of the Massachusetts Department of
700 Transportation and the Massachusetts Bay Transportation Authority for the repair,
701 reconstruction, replacement or demolition of existing state highway, authority and municipally-
702 owned bridges, including the immediate approaches necessary to connect the bridges to the
703 existing adjacent highway and rail system, in which the design is substantially the functional
704 equivalent of, and in similar alignment to, the structure to be reconstructed or replaced; provided,
705 however, said section 61 and said sections 62A to 62I, inclusive, of said chapter 30 shall apply to

706 the repair, reconstruction, replacement or demolition project where the project requires a
707 mandatory environmental impact report pursuant to 301 CMR 11.00, and all work shall be
708 subject to the requirements of the then current edition of the Massachusetts Department of
709 Transportation’s Stormwater Handbook as approved by the department of environmental
710 protection under applicable law. Notice of any application to the department of environmental
711 protection for a water quality certification shall be published in the Environmental Monitor, and
712 the work shall be subject to performance standards prescribed by the department of
713 environmental protection pursuant to section 401 of the Federal Clean Water Act if applicable to
714 the project. Notwithstanding any other provision of this section, said section 61 and said sections
715 62A to 62I, inclusive, of said chapter 30, said chapter 91 and said section 40 of said chapter 131
716 shall apply to any portions of the bridge and roadway approaches to the crossing of the Charles
717 river for the Central Artery and Tunnel Project. If any state highway, authority or municipal
718 bridge crosses over a railroad right-of-way or railroad tracks, the department or authority, as
719 applicable, shall seek the opinion of a railroad company, railway company or its assigns
720 operating on the track of a necessary clearance between the track and the bridge, but the
721 department and the authority and their agents or contractors may enter upon any right-of-way,
722 land or premises of a railroad company or railway company or its assigns for purposes that the
723 department or authority may consider necessary or convenient to carry out this section. If a
724 flagman is needed to carry out the section, the railroad company, railway company or its assigns
725 shall provide the flagman, the cost which shall be borne by the bridge project except in the case
726 of a bridge transferred pursuant to chapter 634 of the acts of 1971. For the purposes of this
727 section, “bridge” shall include any structure spanning and providing passage over water, railroad
728 right-of-way, public or private way, other vehicular facility or other area. Any project exempted
729 from any law pursuant to this section shall be subject to the public consultation process required
730 by the then current version of the Massachusetts Department of Transportation’s Project
731 Development and Design Guidebook.

732 SECTION 20. Notwithstanding any general or special law to the contrary, each city or
733 town that receives reimbursement for the construction and reconstruction of municipal ways
734 under item 6122-1224 shall prepare and deliver to the Massachusetts department of
735 transportation, on or before October 31, 2014, a five year plan for such construction or
736 reconstruction. The city or town may use money made available from item 6122-1224 to prepare
737 such a plan. A city or town may develop a regional plan under this section in collaboration with
738 other cities or towns, or the regional planning agency containing the city or town, as long as that
739 plan also provides for the regional pooling of spending by each participating city or town, and
740 for the distribution or reimbursements paid under item 6122-1224 among the participating cities
741 or towns.

742 SECTION 21. The secretary of administration and finance and the secretary of
743 transportation shall submit a report on the progress of any projects funded under this act and
744 included in the Massachusetts Department of Transportation’s 5-year capital investment plan to

745 the clerks of the senate and house of representatives, the chairs of the senate and house
746 committees on ways and means, and the chairs of the senate and house committees on bonding,
747 capital expenditures and state assets. The report shall include, but not be limited to: (1) previous
748 year planned spending; (2) previous year spending; (3) current year planned spending; (4)
749 current year spending to date; (5) original estimated total project cost; and (6) project description
750 and location of the project. The report shall be submitted on June 30 and December 31 of each
751 year for a period of 8 years after the effective date of this act.

752 SECTION 22. Notwithstanding any general or special law to the contrary, the
753 unexpended balances of all capital accounts authorized in chapter 86 of the acts of 2008, chapter
754 233 of the acts of 2008, chapter 303 of the acts of 2008, chapter 10 of the acts of 2011, chapter
755 133 of the acts of 2012 and chapter 242 of the acts of 2012 which otherwise would revert on
756 June 30, 2013, but which are necessary to fund obligations during fiscal year 2014, are hereby
757 re-authorized through June 30, 2014.

758 SECTION 23. There shall be a special commission to conduct a study of the metropolitan
759 planning organizations. The commission shall consist of 15 members: 3 members of the senate, 1
760 of whom shall be the senate chair of the joint committee on transportation and serve as co-chair,
761 1 of whom shall be the senate chair of the joint committee on municipalities and regional
762 government and 1 of whom shall be appointed by the minority leader of the senate; 3 members
763 of the house of representatives, 1 of whom shall be the house chair of the joint committee on
764 transportation and serve as co-chair, 1 of whom shall be the house chair of the joint committee
765 on municipalities and regional government and 1 of whom shall be appointed by the minority
766 leader of the house of representatives; the chairman of board of the Massachusetts Department of
767 Transportation; the secretary of administration and finance or a designee; the general manager of
768 the Massachusetts Bay Transportation Authority or a designee; 1 member appointed by the
769 governor from a list of 3 nominees submitted by the Massachusetts Association of Regional
770 Transit Authorities; 1 member appointed by the governor from a list of 3 nominees submitted by
771 the Massachusetts Railroad Association; 1 member appointed by the governor who is an expert
772 in transportation finance or transportation planning and is employed at a private or public
773 Massachusetts institution for higher education; 1 member appointed by the governor who is a
774 representative of a business association; and 2 members appointed by the governor from a list of
775 5 nominees submitted by the Massachusetts Association of Regional Planning Agencies. The
776 study shall include, but not be limited to, an analysis of (1) the current metropolitan planning
777 organizations' process; (2) potential ways to simplify and streamline the administration and
778 project selection process; (3) ways to better coordinate between regional metropolitan planning
779 organizations; (4) the potential for the creation of sub-regions; and (5) best practices and models
780 from other states' regional planning organizations. The commission shall conduct its first
781 meeting not more than 60 days after the effective date of the act and shall hold not less than 3
782 public hearings in distinct regions of the commonwealth. The commission shall consult with
783 relevant agencies of the United States Department of Transportation. The commission shall

784 report the results of its study, together with drafts of legislation, if any, necessary to carry its
785 recommendations into effect, by filing the report with the clerks of the senate and house of
786 representatives, who shall forward the report to the joint committee on transportation and the
787 house and senate committees on bonding, capital expenditures and state assets on or before
788 October 31, 2014.

789 SECTION 24. (a) For the purposes of this section the following words shall have the
790 following meanings: -

791 “Department”, the Massachusetts Department of Transportation.

792 “Program”, the complete streets certification program.

793 “Complete streets”, streets that provide accommodations for users of all transportation
794 modes, including, but not limited to, walking, cycling, public transportation, automobiles and
795 freight.

796 “Certified municipality”, a city or town that has been certified by the department pursuant
797 to subsection (c).

798 (b) The department shall establish a complete streets certification program. The purpose
799 of the program shall be to encourage municipalities to regularly and routinely include complete
800 streets design elements and infrastructure on locally funded roads.

801 (c) To be certified as a complete streets community, a municipality shall: (1) file an
802 application with the department in a form and manner prescribed by the department; (2) adopt a
803 complete streets by-law, ordinance or administrative policy in a manner which shall be approved
804 by the department and shall include at least 1 public hearing; provided, that the by-law,
805 ordinance or policy shall identify the body, individual or entity responsible for carrying out the
806 complete streets program; (3) coordinate with the department to confirm the accuracy of the
807 baseline inventory of pedestrian and bicycle accommodations in order to identify priority
808 projects; (4) develop procedures to follow when conducting municipal road repairs, upgrades or
809 expansion projects on public rights-of-way in order to incorporate complete streets elements; (5)
810 establish a review process for all private development proposals in order to ensure complete
811 streets components are incorporated into new construction; (6) set a municipal goal for an
812 increased mode share for walking, cycling and public transportation, where applicable, to be met
813 within 5 years and develop a program to reach that goal; and (7) submit an annual progress
814 report to the department. Certified municipalities shall be eligible to receive funding pursuant the
815 program.

816 (d) Municipalities may adopt this section in the following manner: in a city having a Plan
817 D or Plan E charter, by the city manager; in any other city, by the mayor; in a town, by vote of
818 the board of selectmen.

819 (e) The department shall adopt rules, regulations or guidelines for the administration and
820 enforcement of this section, including, but not limited to, establishing applicant selection criteria,
821 funding priority, application forms and procedures, grant distribution and other requirements.

822 (f) The governor shall appoint an advisory committee to assist the department in
823 developing the rules, regulations or guidelines for the program, including the development of a
824 model complete streets by-law or ordinance. The advisory committee shall consist of the
825 following members, as appointed by the governor: 3 persons who are members of 3 different
826 regional planning agencies in the Massachusetts Association of Regional Planning Agencies, 2
827 persons who are residents of gateway municipalities, as defined by section 3A of chapter 23A of
828 the General Laws, and 1 person from each of the following organizations: Metropolitan Area
829 Planning Council, the department of public health, the Massachusetts Municipal Association, the
830 Massachusetts Bicycle Coalition, WalkBoston, the Livable Streets Alliance and the
831 Massachusetts Association of Chambers of Commerce Executives.

832 (g) The department shall annually, on or before April 1, submit a report detailing the
833 program's progress during the previous calendar year to the clerks of the senate and the house of
834 representatives who shall forward the same to the joint committee on transportation and the joint
835 committee on public health.

836 SECTION 25. Notwithstanding any general or special law to the contrary, the department
837 of housing and community development shall consider the town of Stoughton as an eligible
838 location for the purposes of chapter 40R of the General Laws and shall assist the town in
839 developing a plan to revitalize the town center by identifying projects that could accompany the
840 construction of a planned new rail station.

841 SECTION 26. Notwithstanding any general or special law to the contrary, the
842 unexpended and unencumbered balances of the bond-funded authorizations in the following
843 accounts shall cease to be available for expenditure 90 days after the effective date of this act:

849 6620-7967, 6620-9510, 6620-9610, 6125-9716, 6125-9934, 6125-9936, 6125-9717, 6125-9937.
