An Act authorizing the Division of Capital Asset Management and Maintenance to grant to the town of Brookfield 6 easements over certain parcels of land in the town of Brookfield.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith the granting of easements over certain parcels of land in the town of Brookfield, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Be it enacted by the Senate and House of Representatives in General Court assembled,

3 SECTION 1. Notwithstanding sections 32 to 37, inclusive, of chapter 7C of the General  
4 Laws or any other general or special law to the contrary, the commissioner of capital asset  
5 management and maintenance, in consultation with the commissioner of fish and game, may  
6 grant 6 easements to the town of Brookfield for the reconstruction of the Fiskdale road, state  
7 highway route 148, bridge, The easements are shown as: (i) parcel X-S-2, to construct and  
8 maintain slopes and to construct a new guardrail; (ii) parcel X-S-5, to construct and maintain  
9 slopes; (iii) parcel X-E-2 for the layout, alteration, construction and maintenance of a sidewalk;  
10 (iv) parcel X-E-5, for the layout, alteration, construction and maintenance of a sidewalk); (v)  
11 parcel X-D-2, to construct flared end section for proposed drainage; and (vi) parcel X-TE-1, to  
12 construct and maintain slopes on a plan entitled “Brookfield, Massachusetts Town of Brookfield  
13 Easement Plan Fiskdale Road – Route 148,” dated August 9, 2013, revised through August 23,  
14 2013, prepared by Green International Affiliates, Inc., which is on file at the offices of the

15 department and such easement areas shall be under the care, custody, management and control of  
16 the board of selectmen of the town.

17 SECTION 2. In consideration for the grant of the easements authorized in section 1, the  
18 town of Brookfield shall convey to the department of fish and game for conservation and passive  
19 recreational purposes a certain parcel of land described in an order of taking dated April 26, 2012  
20 and recorded with the Worcester south district registry of deeds in book 48964, page 1,.

21 SECTION 3. The relative full and fair market value of the easements described in  
22 section 1 and the parcel described in section 2 shall be determined by the commissioner of the  
23 division of capital asset management and maintenance based on at least 1 professional appraisal.

24 SECTION 4. Notwithstanding any general or special law to the contrary, the inspector  
25 general shall review and approve any appraisal conducted pursuant to section 3. The inspector  
26 general shall prepare a report of the review of the methodology utilized for the appraisal and  
27 shall file the report with the commissioner of capital asset management and maintenance. Within  
28 15 days after receiving the inspector general's report but not later than 15 days before the  
29 execution of any agreement or document under this act, the commissioner shall submit the report  
30 to the house and senate committees on ways and means and the joint committee on state  
31 administration and regulatory oversight.

32 SECTION 5. Costs and expenses associated with the transactions authorized in this act,  
33 including any appraisals, surveys and recordings, shall be borne by the town of Brookfield.
