An Act relative to the Worcester DCU arena and convention center.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 2 of Chapter 522 of the Acts of 2006 is hereby amended by  
2 deleting “\$30,000,000” in line 13, and inserting in lieu thereof, “\$60,000,000.”

3           SECTION 2. Section 2 of Chapter 422 of the Acts of 2006 is hereby amended by  
4 inserting after the word “act” in line 14, the following provision: - “provided, however, that prior  
5 to the issuance of any funds pursuant to a loan order adopted under the authority of this act, the  
6 city manager, and the city treasurer and collector of taxes, shall file a report with the city council  
7 stating that revenues expected to be delivered by the city pursuant to Section 3(a) of this act.”

8           SECTION 3. Section 3(b) of Chapter 422 of the Acts 2006 is hereby amended by  
9 inserting after “44” in line 67, the following: - “plus the approximate 0.90 acre parcel located at  
10 65 Prescott Street, plus the approximate 0.24 acre parcel of land at 205 Summer Street, plus the  
11 approximate 1.09 acre parcels located at 212 Summer Street, plus the approximate 0.92 acre  
12 parcel shown as Area of Washington Square To Be Discontinued, on a plan of land prepared by  
13 BSC Group, Inc., titled Discontinuance Of A Portion Of Washington Square, dated June 6, 2013,  
14 to be recorded in the Worcester district registry of deeds, plus the approximate 4.28 acre parcel  
15 located at 2 Main Street, plus the approximate 2.42 acre parcel located at 1 Lincoln Square, plus,  
16 but only for the purpose of the receipts identified by section 3(a)(iii) of this act, the approximate  
17 1.33 acre parcel of land consisting of parcels P-1, P-2, and O-1, on a plan of land prepared by  
18 Nitsch Engineering, titled Approval Not Required Plan, date November 29, 2012, to be recorded  
19 in the Worcester district registry of deeds.”
