The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act establishing college and career preparation programs and opportunities for postsecondary education.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. Section 1B of said chapter 69 of the General Laws is hereby further amended
2 by adding the following sentence at the end thereof :-

3 The board of education shall establish a college and career preparation program for
4 students with a range of educational and academic experiences in and outside the classroom,
5 including but not limited to, an emphasis on experiences that will motivate disadvantaged and
6 minority students to attend college.

7 Section 2. Chapter 69 of the General Laws is hereby further amended after Section 10A
8 by adding the following new section:-

9 Section 10B. College and career preparation programs and opportunities for
10 postsecondary education

11 The Board shall establish rules and regulations governing the implementation and
12 administration of a college and career preparation program, which shall provide for the early
13 identification and enrollment of students in a college preparation program with a range of
14 educational and academic experiences in and outside the classroom, including an emphasis on
15 experiences that will motivate disadvantaged and minority students to attend college.

16 The Board shall establish guidelines by which the school committee of a city, town, or
17 regional school district participating under the provisions of this act, may prepare and submit to
18 the board for its approval, a plan for college and career programs to integrate college and career
19 readiness into both the curriculum and academic mission of the school to keep pace with 21st
20 century skill and knowledge needs.

21 For the purposes of this act, any academic and career program shall begin development of
22 a plan for each seventh-grade student with completion by the fall of the student's eighth-grade
23 year.

24 Each student enrolled in the college and career preparation program shall be counseled on
25 opportunities for beginning post-secondary education and opportunities for obtaining industry
26 certifications, occupational competency credentials, or professional licenses in a career and
27 technical education field prior to high school graduation. Such opportunities shall include access
28 to at least three Advanced Placement courses or three college-level courses for degree credit
29 pursuant to section 39 of said chapter 15A. Students enrolled in such courses shall not be denied
30 participation in school activities for which they are otherwise eligible.

31 Each student enrolled in an individual college and career preparation program afforded
32 opportunities to take courses simultaneously for high school graduation and postsecondary credit
33 shall be deemed eligible under the following conditions:

34 (a) Written approval of the high school principal prior to participation in dual
35 enrollment must be obtained;

36 (b) The college must accept the student for admission to the course or courses; and

37 (c) The course or courses must be given by the college for degree credits

38 All schools shall begin development of an individual college and career preparation
39 program for each seventh-grade student with completion by the fall of the student's eighth-grade
40 year. Students who transfer from other than a Massachusetts public school into the eighth grade
41 or beyond, shall have an individual college and career preparation program developed upon
42 immediate enrollment.

43 The components of an individual college and career preparation program shall include,
44 but not be limited to, the student's program of study for high school graduation and a
45 postsecondary career pathway based on the student's academic and career interests. The
46 individual college and career preparation program shall be developed in accordance with the
47 guidelines established by the Board and signed by the student, student's parent or guardian, and
48 school official(s) designated by the principal.

49 The individual college and career preparation program shall be included in the student's
50 transcript and shall be reviewed and updated, if necessary, before the student enrolls into the

51 ninth and eleventh grades. A city, town, or regional school shall be deemed to have met its
52 obligation for parental involvement under the condition of good faith to notify the parent or
53 guardian of the responsibility for the development and approval of the individual college and
54 career preparation program.

55 Section 3. This act shall take effect immediately upon passage.
