An Act relative to timely classification of sex offenders..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Section 178L of chapter 6 of the General Laws, as appearing in the 2010
 Official Edition, is hereby amended by striking out the figure "60" and inserting in place thereof
 the following figure:- 90.

4 SECTION 2. Said section 178L of said chapter 6 of the General Laws, as so appearing, is 5 hereby further amended by inserting after the word "evidence", in line 22, the following words:-

6 "; provided, however, that in no case shall the sex offender submit any information less 7 than 30 days prior to release or parole.".

8 SECTION 3. Said section 178L of said chapter 6 of the General Laws, as so appearing,
9 is hereby further amended by inserting after the word "shall", in line 23, the following words:-

10 ", prior to the release or parole of the sex offender,".

SECTION 4. Said section 178L of said chapter 6 of the General Laws, as so appearing,
is hereby further amended by striking the figure "20", in line 35, and inserting in place thereof
the following figure:- "15".

- 14 SECTION 5. Said section 178L of said chapter 6 of the General Laws, as so appearing, 15 is hereby further amended by inserting after the figure (2), in line 37, the following words:-
- ; provided, however, that the board shall make every effort to conduct such hearingbefore the date of release or parole of the sex offender".
