**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act relative to preserving Polish heritage in the Pioneer Valley.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Whereas, the Pioneer Valley is the home to a higher percentage of people  
2 of Polish heritage than any other area of Massachusetts, and

3           Whereas, public colleges and universities have suffered reductions in funding for studies  
4 of the arts and humanities during the past several years, and

5           Whereas, the documentation, preservation and research of this heritage and the  
6 contributions of the Polish people to the socioeconomic vitality of this region and the  
7 Commonwealth is an important public policy goal, therefore

8           There is hereby established a special commission to investigate and support the  
9 preservation of Polish culture and history in the Pioneer Valley. The purpose of said special  
10 commission shall be to promote public support and funding of Polish cultural preservation  
11 activities in western Massachusetts, and to compliment those activities that acknowledge the  
12 contributions people of Polish heritage have made and continue to make to the Pioneer Valley  
13 and the Commonwealth of Massachusetts. Said commission shall evaluate the public and private  
14 resources available to preserve and research Polish language, history, culture, genealogy and the  
15 immigrant experience. Said commission will serve as a public clearinghouse for legislative and  
16 private efforts to secure additional funding for archival and educational efforts.

17           Said special commission shall be comprised of three members of the House of  
18 Representatives, appointed by the Speaker, of which at least two shall be of Polish heritage; two  
19 members of the Senate, appointed by the Senate President; three members appointed by the  
20 Governor, in consultation with the legislative delegation representing the Pioneer Valley, all of  
21 which shall be officers in Polish heritage or Polish genealogical organizations located in  
22 Hampshire, Hampden or Franklin counties and one member to be recommended by the chair of  
23 the Slavic studies department at the University of Massachusetts at Amherst.

24           Said special commission may receive funding through state appropriation for the  
25 purposes of this act, provided that a state college or community college located in the Pioneer  
26 Valley, may allocate meeting room space for the purposes of said special commission, and  
27 provided further, that the special commission shall file its report, including a fiscal note, with the  
28 Clerks of the House and Senate, the Chairmen of the House and Senate committees on ways and  
29 means, no later than July 1, 2016.
