**The Commonwealth of Massachusetts**

**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act providing a homeless bill of rights.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 23B of the General Laws is hereby amended by adding the following section:-

2 Section 31. (a) The general court finds and declares that:

3 At the present time, many persons have been rendered homeless as a result of economic  
4 hardship, a severe shortage of safe, affordable housing and a shrinking social safety net.

5 (b) For purposes of this section, “experiencing homelessness” shall mean the status of  
6 having or not having a fixed or regular residence, including the status of living on the streets or  
7 in a homeless shelter or similar temporary residence.

8 (c) No person's rights, privileges, or access to public services may be denied or abridged  
9 solely because he or she is experiencing homelessness. Such a person shall be granted the same

10 rights and privileges as any other resident of the commonwealth. A person experiencing  
11 homelessness shall have:

12 (1) The right to use and move freely in public spaces, including, but not limited to, public  
13 sidewalks, public parks, public transportation and public buildings, in the same manner as any  
14 other person, and without discrimination on the basis of his or her experiencing homelessness;

15 (2) The right to equal treatment by all state and municipal agencies, without  
16 discrimination on the basis of his or her experiencing homelessness;

17 (3) The right not to face discrimination while seeking or maintaining employment due to  
18 his or her lack of permanent mailing address, or his or her mailing address being that of a shelter  
19 or social service provider;

20 (4) The right to emergency medical care free from discrimination based on his or her  
21 experiencing homelessness;

22 (5) The right to vote, register to vote and receive documentation necessary to prove  
23 identity for voting without discrimination due to his or her experiencing homelessness;

24 (6) The right to protection from disclosure of his or her records and information provided  
25 to homeless shelters and service providers to state, municipal and private entities without  
26 appropriate legal authority; and the right to confidentiality of personal records and information in  
27 accordance with all limitations on disclosure established by the United States Department of  
28 Housing and Urban Development, the Federal Health Insurance Portability and Accountability  
29 Act, and the Federal Violence Against Women Act; and

30           (7) The right to a reasonable expectation of privacy in his or her personal property to the  
31 same extent as personal property in a permanent residence.

32           (d) The rights contained in subsection (c) shall serve the same purpose as a statement of  
33 legislative intent that will help guide the department and other state and municipal agencies to  
34 promote the rights of those experiencing homelessness. These principles shall not be interpreted  
35 to create a private right of action, to form the predicate for a right of action under any other state  
36 or federal law or to create liability that would not exist absent the foregoing principles.
