In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act amending laws relative to certain judicial procedures.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. The fourth paragraph of section 34M of chapter 90 of the General Laws, as
2	appearing in the 2012 Official Edition, is hereby amended by adding the following two
3	sentences:- If after the commencement of any such action, but before judgment, the insurer
4	makes payment of the amount that is due and payable, the court may still assess costs and
5	reasonable attorney's fees for the bringing and prosecuting of the action, but only up until the
6	time of such payment. Interest, running from the commencement of the action shall be assessed
7	on all amounts adjudged to be due and payable in any such action, at the same rate as interest is
8	assessed for breach of contract actions in the commonwealth.
0	SECTION 2 Section 70A of chapter 111 of the General Laws, as appearing in the 2012

9 SECTION 2. Section 70A of chapter 111 of the General Laws, as appearing in the 2012
10 Official Edition, is hereby amended by adding the following sentence:- The expense of any

11 attorney's fees and costs incurred in enforcing the liability of the tortfeasor and in obtaining such 12 judgment, compromise or settlement shall be divided between the health maintenance 13 organization, or hospital, medical or dental service corporation and the injured person in 14 proportion to the amounts received by them from any such judgment, settlement or compromise. 15 If the settlement, judgment or funds available to satisfy the judgment are less than the amount of 16 plaintiff's total damages, the court may reduce after a hearing the amount of said insurer's lien in 17 the action, after evaluation of the plaintiff's total cognizable damages at law. 18 SECTION 3. Chapter 111 of the General Laws, as so appearing, is hereby amended by 19 inserting after section 70D the following section:-20 Section 70D ¹/₂. Notwithstanding the provisions of sections 70A to 70D, inclusive, and 21 any contractual term to the contrary, no health maintenance organization or group or individual 22 medical insurer or disability insurer which has provided benefits for covered services to a person 23 insured in an accident shall have a lien or right of reimbursement or subrogation claim or claims 24 of recoupment no matter how designated upon any recovery or sum had or collected or to be 25 collected, whether by judgment or by settlement or compromise from another person as damages 26 on account of such injuries, for more than the proportionate share of said recovery or sum subject 27 to its lien, right or reimbursement, subrogation claim or claims of recoupment which the amount 28 of benefits so provided for covered services bears to the complete value of the injured person's 29 tort damages.

Either the entity which provided benefits or the injured person may petition the court in which the accident case is pending, or in a court in which such case could be properly filed had settlement not been attained before commencement of suit, for a determination of the

reasonableness of the settlement and the fair allocation of amounts payable thereunder. A hearing
on such petition shall adhere to the same procedural requirement as provided in section 15 of
chapter 152.

36 SECTION 4. Chapter 231 of the General Laws, as appearing in the 2012 Official Edition,
 37 is hereby amended by inserting after section 72 the following section:-

38 Section 72A. In any action in which an injured person enters into a settlement with, or 39 obtains a judgment upon trial from a third party and benefits for such person's injuries have been 40 paid under chapter 152, and the injured person and the insurer paying said benefits do not agree 41 to the amount each is entitled to recover out of such settlement or judgment, there shall be a just 42 and reasonable apportionment thereof in accordance with this section; provided, however if the 43 settlement, judgment or funds available to satisfy the judgment are less than the amount of 44 plaintiff's total damages, the court or other authority authorized to approve settlements under 45 section 15 of chapter 152 may reduce after a hearing the amount of said insurer's lien in the 46 action, after evaluation of the plaintiff's total cognizable damages at law. Except in the case of a 47 final judgment, where the plaintiff is dissatisfied with the apportionment by the court, he may 48 withdraw his consent to the settlement.

49 SECTION 5. Said chapter 231 is hereby further amended by inserting after section 85AA
50 the following section:-

51 Section 85BB. Any waiver, disclaimer, exclusion or limitation of liability in an 52 employment application or other document purporting to release any third party from liability for 53 injuries or death, whether in tort or contract, to an employee shall be void as against public 54 policy, and no employee or employment applicant shall be required to agree to such waiver,

55 disclaimer, exclusion or limitation of liability as a condition of his or her hiring or continued 56 employment. The term "employee" as used in this section shall be as defined in section 1 of 57 chapter 152, and shall include dependents of such employee, also as so defined, except that it 58 shall not exclude an independent contractor, or any employee thereof, providing labor or 59 materials to another. Any employer who violates this section shall be liable for a penalty equal to 60 2 times the average weekly wage in the commonwealth plus the attorney's fees and costs incurred by the employee in any action involving a determination of the rights of the employee 61 under this section. 62
