An Act regulating sex offender registration in the 21st century.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 178C of Chapter 6 of the General Laws, as appearing in the 2004  
2 Official Edition, is hereby amended by inserting after the definition of “Agency”, the following  
3 new definition:- “Electronic alias, address and domain”, any electronic mail, website  
4 registrations, messaging and chat service aliases, websites and domains either personally owned  
5 and operated or otherwise owned and operated by a third party with the purpose of displaying,  
6 soliciting or otherwise posting information, entries and aliases associated with either web-based  
7 applications and databases, or aliases used and/or stored on personal computers that may be  
8 transmitted for use during any communication.

9 SECTION 2. Section 178D of Chapter 6 of the General Laws, as appearing in the 2004  
10 Official Edition, is hereby amended in subparagraph (a) by inserting after the words “aliases  
11 used,” in line 11 the following:- all electronic aliases, addresses and domains
