The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to the mandated reporter law.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 51A of chapter 119 of the General Laws, as most recently amended
- 2 by section 10 of chapter 178 of the acts of 2011, is hereby further amended by striking out the
- 3 first paragraph and inserting in place thereof the following paragraph:-
- 4 (a) A mandated reporter who, in his or her professional capacity, has reasonable
- 5 cause to believe that a child is suffering physical or emotional injury resulting from: (i) abuse
- 6 inflicted upon him which causes harm or substantial risk of harm to the child's health or welfare,
- 7 including sexual abuse; (ii) neglect, including malnutrition; (iii) physical dependence upon an
- 8 addictive drug at birth, (iv) being a sexually exploited child; or (v) being a human trafficking
- 9 victim as defined by section 20M of chapter 233, shall immediately communicate with the
- department orally and, within 48 hours, shall file a written report with the department detailing

- 11 the suspected abuse or neglect. A mandated reporter who, in his or her professional capacity,
- becomes aware of a sexually exploitative relationship between a child under the age of 18 and
- another mandated reporter, shall immediately communicate with the department orally and,
- within 48 hours, shall file a written report with the department detailing the suspected
- 15 exploitation.
