Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 27A of chapter 221, as appearing in the 2012 Official Edition, is

8 striking out, in line 16, the figure “(3)” and inserting in place thereof the following figure:- (2)

10 striking out, in lines 31-32, the words “and in the case of a district court, without an order of the
11 standing justice of such district court.”
