**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act adjusting the salaries of justices of the judicial branch.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 22 of chapter 211 of the General Laws, as most recently amended
2 by sections 2 and 4 of chapter 61 of the acts of 2013, is hereby amended by striking the figure
3 “\$166,239” and inserting in place thereof the figure “\$172,889”.

4 SECTION 2. Said section 22 is hereby further amended by striking the figure
5 “\$172,889”, inserted by section 1, and inserting in place thereof the figure “\$179,805”.

6 SECTION 3. Said section 22 is hereby further amended by striking the figure “\$160,984”
7 and inserting in place thereof the figure “\$167,423”.

8 SECTION 4. Said section 22 is hereby further amended by striking the figure
9 “\$167,423”, inserted by section 3, and inserting in place thereof the figure “\$174,120”.

10 SECTION 5. Section 2 of chapter 211A of the General Laws, as most recently amended
11 by sections 6 and 8 of chapter 61 of the acts of 2013, is hereby further amended by striking the
12 figure “\$170,358” and inserting in place thereof the figure “\$177,172”.

13 SECTION 6. Said section 2 is hereby further amended by striking the figure “\$177,172”,
14 inserted by section 5, and inserting in place thereof the figure “\$184,259”.

15 SECTION 7. Said section 2 is hereby further amended by striking the figure “\$165,087”
16 and inserting in place thereof the figure “\$171,690”.

17 SECTION 8. Said section 2 is hereby further amended by striking the figure “\$171,690”,
18 inserted by section 7, and inserting in place thereof the figure “\$178,558”.

19 SECTION 9. Section 4 of Chapter 211B of the General Laws, as most recently amended
20 by Section 10 of Chapter 61 of the Acts of 2013, is hereby amended by striking the figures
21 “\$159,694” and inserting in place thereof the figure “\$166,082”.

22 SECTION 10. Said section 4 is hereby further amended by striking the figures
23 “\$166,082”, inserted by section 9, and inserting in place thereof the figure “\$172,725”.

24 SECTION 11. Section 4 of Chapter 211B of the General Laws, as most recently
25 amended by Section 12 of Chapter 61 of the Acts of 2013, is hereby amended by striking the
26 figure “\$165,124” and inserting in place thereof the figure “\$171,729”.

27 SECTION 12. Said section 4 is hereby further amended by striking the figure
28 “\$171,729”, inserted by section 11, and inserting in place thereof the figure “\$178,598”.

29 SECTION 13. Section 4 of Chapter 211B of the General Laws, as most recently
30 amended by Sections 14 of Chapter 61 of the Acts of 2013, is hereby amended by striking the
31 figure “\$170,358” and inserting in place thereof the figure “\$185,742”.

32 SECTION 14. Said section 4 is hereby further amended by striking the figure
33 “\$185,742”, inserted by section 13, and inserting in place thereof the figure “\$193,172”.

34 SECTION 15. Sections 1, 3, 5, 7, 9, 11 and 13 of this act shall take effect July 1, 2015.

35 SECTION 16. Sections 2, 4, 6, 8, 10, 12 and 14 of this act shall take effect January 1,
